The claim in the original suit was
to recover a balance due on a bond.

This special appeal is from a decision
in Appeal (N^o. 188 of 1858) by the Acting Judge
of the Zillah of Dhawar, affirming, with costs, the de-
cree in the original suit of the Sud der Ameer who
awarded payment of the claim of Eshwunt Venka-
jee the original Plaintiff.

Whereat Balapa being dissatisfied
made special appeal in the Suder Dewanee Adawlat
on the grounds,

1st. That the refusal to file the receipt was
contrary to law.

2nd. That according to No. 55 of the Certified list the receipt does not require a stamp.

The Court reverse the Judge's decree and remand the case in order that the Defendant may have an opportunity of proving that the receipt produced by him is genuine and that a new decree on merits may be passed awarding costs.
