The claim in the original suit was to recover the rent for some land.

In appeal, N^o 533 of 1858, the joint judge of the zillah of Dharwar affirmed, with costs on Lokapa, the decree of the Moonsiff of Chikodee, who awarded the amount claimed.

Dissatisfied, Lokapa made Special Appeal in the Sudder Dewanee Adawlut on the grounds, that the joint judge was in error in awarding the income of land before deciding as to its proprietorship; and that he was wrong in ruling that this suit was cognizable in any but a revenue Court under Act XVI of 1838.

The Court under the provisions of Act XVI of 1838 annul the decree of the joint judge and refer the suit for decision to the collector of Dharwar. Costs to follow the final decision.
