The claim in the original suit was to recover with costs ~~via~~ from the purchaser of mortgaged house, the amount of a decree obtained against it.

In Appeal, N^o 40 of 1859, the Acting Judge of the Zillah of Sholapoor, affirmed with costs on the heirs of Olajee, the decree of the Moonsiff of Barshee who awarded payment of the amount claimed, or restitution of the mortgaged property.

Dissatisfied, the heirs of Olajee made Special Appeal in the Sudder Dewanee Adawlat arguing that the Acting Judge's decree is opposed to Law in upholding against them personally Yenkajee's demand for payment, instead of throwing it out, and leaving him to attach the property against which he had obtained a decree.
