The claim in the original suit was to recover  
as the claimant's share of the family estate, a one  
third share of two fields in the Inam Village of  
Hoodlee.

In appeal, N<sup>o</sup> 210 of 1859, the Assistant  
judge of the Zillah of Dharwar affirmed with  
costs on Bhimajee the decree of the Moonsiff of  
Belgaum who awarded, in favor of the claim of  
Ramajee.

Dissatisfied, Bhimajee made Special  
appeal in the Sudr Dewanee Adawlut urging 1<sup>st</sup>  
that the document N<sup>o</sup> 3 not being sufficiently  
stamped the Assistant Judge should not have  
admitted it as evidence; 2<sup>nd</sup> that according to Law

and

and Practice the supplemental petition given in by the Plaintiff should not have been received at the late date on which it was put in; 3<sup>rd</sup> That the decision is illegal under Regulation IV of 1827 Section 25.

The Court confirm the decree of the assistant judge with costs.
