The claim in the original Suit was
to recover a sum of money, amounting principal
and interest as stipulated in the bond, to Rupees 100.

In cross Appeals Nos 683 and 698 of 1858
the joint Judge of the Zillah of Dharwar affirmed
with costs of Appeal on the respective Appellants,
the decree of the Sudder Ameen of Hooblee who
awarded to Mahomed Sahib Rupees 40, being the
principal, Rupees 20 with interest equal to the principal,
and rejected the remainder of the claim for
interest, with costs of the amount of claim admitted
upon Sadli' & ca, and of that rejected upon Mahomed
Sahib.

Dissatisfied, Mahomed Sahib made
Special Appeal in the Sudder Dewanee Adawlat
urging that the joint Judge's decree is opposed to
Law in that he has not awarded him interest,
as stipulated in the bond.

The Court amend the decrees of the Joint Judge and award to Mahomed Sahib the additional amount of interest sued for, with costs.
