The claim in the original suit was to recover damages alleged to have been caused by the defendants having opened a door into and established a use of way upon certain land.

In Appeal N^o 165 of 1859 the Judge of the Sillah of Khandesh affirmed with costs on Soorjmul the decree of the Moonsiff of Basra who threw out the claim.

Dissatisfied Soorjmul preferred a special Appeal in the Sudder Court urging that the decision of the Judge is contrary to Law inasmuch as he decided the case instead of remanding it in order that the Moonsiff might dispose of it on its merits.

The Court confirm the decree of the Lillah Judge and direct that each party bear his own costs.
