The claim in the original suit was to recover possession of some gutkooler land.

In appeal, No 96 of 1858, the Principal Sudder Ameen of Ahmednuggur affirmed with costs on Mahiputee, the decree of the Mooniff of Ahmednuggur who on a reinvestigation of the case on remand, ordered the land to be restored to Arjoonjee.

Dissatisfied, Mahiputee made Special Appeal in the Sudder Dewanee Adawlat on the grounds that the Principal Sudder Ameen has misconstrued the document No 104, the land in dispute not being therein denominated Miras as set forth by him; and 2^{ndly}, that Respondents' Razeenamada is true, notwithstanding which his claim has

been rejected.

The Court reverse the decree of the Principal Sudder Ameen and reject Respondents' claim with costs.
