The claim in the original suit was to recover
from the appellant as security, and two others as
principals, the sum of Rupees 49-3-11 due on a bond.

In appeal, N^o 48 of 1858, the Collector of
Rutnaghery amended the decree of the Mamlutdar of
Anjiravel with costs in proportion on appellant
Arunn Salvi bin Chand Salvi and Respondent Dajee
Sawant, and ordered that the former should be respon-
sible to the latter for the amount of Rupees 36-15-11
awarded in his favor by the Mamlutdar, in the event
of its non recovery from the two principals, Buchajee
Salvi bin Soobhan Salvi and Arun Salvi bin Uthad
Salvi.

Dissatisfied, Arun Salvi bin Chand Salvi
preferred.

preferred a Special Appeal in the Sudder Court, urging, that the bond No 12 and the examination of the Respondents' Vakeel No 9 have been misconstrued.

The Court modify the decision of the Collector and reject the claim against the appellant, Anand Salvi the security, with costs.
