The claim in the original suit was to recover Rs 2-15-6 alleged to be due as Government assessment, with interest annas 8.

In Appeal No 69 of 1858 the collector of Putrajy reversed with costs on Chinto the decree of the Mambuldar of Anjumwell and disallowing interest ordered Chinto to pay Krushnrao the Government assessment Rs 2-15-6.

Dissatisfied Chinto preferred a Special Appeal in the Sudder Court urging that the decision is opposed to <sup>Act</sup> XVII of 1838 the claim against him not being one for rent and therefore not within the jurisdiction of the Revenue Courts.

The Court annul the decree of the Collector and refer the suit for trial in the proper Civil Court.
