The claim in the original suit was to recover Rs. 1-8-1 the balance due for Government assessment with interest amounting to 3.

In appeal No. 70 of 1858 the Collector of Putnagberry reversed the decree of the Mamuldar of Anjumwell and disallowed the claim for interest awarded. Krushnarao Rupees 1-8-1 the balance which he claimed as due for Government assessment. Baba bearing his own costs in the original suit and Chinto the remainder with all costs also in Appeal.

Dissatisfied Chinto preferred a special appeal in the Sudder Court arguing that

that the decision is opposed to Act XVI of 1838 the claim against him not being one for rent and therefore not within the jurisdiction of the Revenue Court.

The Court annul the decree of the Collector and refer the suit to be tried in the proper Civil Court.
