The claim in the Original suit was to
recover a balance of Assessment with in-
terest.

In Appeal N^o 68 of 1858 the Col-
lector of Putnagberry reversed the decree
of the Mamlatdar and disallowing interest
awarded the balance claimed (Rupees 2-15-0.)
to Krushnrao and ordered that Vittal should
bear his own costs in the Original suit and
Chinto the remaining costs with all costs
also in Appeal.

Dissatisfied Chinto preferred a
Special Appeal in the Sudder Court urg-
ing that the decision is opposed to Act ~~XVI~~
of 1838 the claim against him not being
one

one for rent and therefore not within the jurisdiction of the Revenue Court.

The Court annul the decree of the Collector and refer the suit to be tried in the proper civil court.
