The claim in the original suit was to prevent the execution of a decree against certain parties as regards the right of way in a certain lane.

In Appeal, N^o 106 of 1858, the Acting Senior Assistant Judge of the Zilla of the Konkan reversed the decree of the Munsiff of Surnee, and threw out the claim with costs on Autos.

Dissatisfied Autos preferred a special appeal in the Sudder Court, urging that the decision is opposed to the ruling in Special Appeal, N^o 3815; 2ndly, that Respondent has presented a durkhast

to execute the decree, therefore the present claim should not have been thrown out.

The Court confirm the decree of the acting Senior Assistant Judge with costs.
