The claim in the Original Suit was to recover possession of land

In Appeal No. 187 of 1863 the Judge of the District of Sattara at Sattara reversed the Decree of the Munsiff Walva who awarded Rent only and not the land.

A Special Appeal was preferred in the High Court on the grounds that (1) the decision of the District Judge is contrary to law, in that the land in question being a service tenure, the District Judge has

has failed to award appellant his share  
 therein, that (2) the District Judge has vir-  
 -tually held the oral, and documenta-  
 -ry evidence in the case recorded, to be  
 inadmissible for the purpose of dis-  
 -turbing Respondent's possession of  
 the land in dispute. That (3) the Dis-  
 -trict Judge has failed to give any  
 opinion as to the credibility of the evi-  
 -dence before him.

The decree of the District Judge  
 affirmed with costs.
