WHEREAS it is expedient to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State of Hyderabad for the service of the year ending on the 31st day of March, 1954;

Preamble.

It is hereby enacted as follows:—

1. (1) This Act may be called the Hyderabad State Supplementary Appropriation (No. 2) Act, 1954.

Short title and commencement.

(2) It shall come into force at once.

2. From and out of the Consolidated Fund of the State of Hyderabad there may be paid and applied sums not exceeding those specified in column 5 of the Schedule amounting in the aggregate to the sum of six crores, seven lakhs, thirty-five thousands, eight hundred and sixty-seven rupees towards defraying the several charges coming in course of payment during the year ending on the 31st day of March, 1954, in respect of the services specified in column 2 of the Schedule.

Issue of Rs, 6,07,35,867 out of the Consolidated Fund of the State of Hyderabad for the year 1953-54.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Hyderabad by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the 31st day of March, 1954.
