**IT IS HEREBY NOTIFIED** for the information of Advocates and Parties appearing in person that **the Hon'ble Shri Justice Ravindra V. Ghuge** has issued the following directions regarding Christmas Vacation 2025 (Vacation Court) from 25<sup>th</sup> December 2025 to 4<sup>th</sup> January 2026:-

1. The Court shall assemble through video conferencing on 29<sup>th</sup> December 2025, 31<sup>st</sup> December 2025 and 3<sup>rd</sup> January, 2026 at 11.00 a.m.

Thereafter, the concerned Advocate shall be informed whether circulation is granted. **Soft copies of the Petition shall be forwarded along with the praecipe.**
