TERMS AND CONDITIONS OF AUCTION SALE

Subject to the reserve price fixed by The Registry of High Court at Bombay, Original Side or persons duly authorized in this regard and of the terms and conditions contained herein all sale shall be made to the highest bidder on “AS IS WHERE IS BASIS” and on “NO COMPLAINT BASIS”.

The Seller : Seller referred in these conditions of sale, is The Registry of High Court, Bombay Original Side, Mumbai- 400 023.

The Bidder : Any person representing as an Individual OR as Proprietor OR as a Partner OR as authorised representative of any company and who is paying the Caution Money Deposit (CMD) and getting Registration is considered as a Registered Bidder. One individual can represent as a bidder on his own behalf or on behalf of this company. But he can't register separately for himself and company at the same time. Bidder must read the terms and conditions of the auction sale very carefully and then only place his signature on the “Registration-cum-Acceptance Form” given in Annexure-A. He is also expected to record his address, PAN, Telephone Numbers, Fax Number, e-mail address, as all communication would be forwarded only at that address. Change in Bidder Name shall not be considered. Right of Admission is reserved by The Registry of High Court, Bombay, Original Side.

The Purchase :The successful bidder is later on verified as the Purchaser.

1. Participation and Registration :

The prospective bidder has to register with The Registry of High Court at Bombay, Original Side, Mumbai on e-auction website : www.eauction.gov.in

The registration can be done by using the Govt authorised DSC. The timetable for registration and e-auction is given below.

End Date : 04/01/2023 to 6.00 p.m.
- D) Auction Date & Time : 05/01/2023 From 10:00 A.M. to 4:00 P.M.
- E) The Inspection of Vehicles can be done from 03/01/2023 and 04/01/2023 the place mentioned in 'Note A' of Annexure 'C'. It can be done on aforesaid dates between 10.00 A.M. to 6.00 P.M.

The prospective bidder shall have to submit pay order/demand draft for **Rs.2,000/- (Rupees Two Thousand Only) for this auction (non-refundable) as Registration charges** in the favour of "Master (ADM), High Court, Bombay" payable at Mumbai. The registration charge and CMD should be submitted on 03.01.2023 and 04/01/2023 between 10.00 a.m. to 6.00 p.m.

The bidders who have already submitted the aforesaid Registration Charges and CMD amount with the office on for before 16.12.2022 as per previous schedule of e-auction of 11 Baleno Cars which was to be conducted on 20.12.2022 but got cancelled due to technical issue, are now not required to pay the aforesaid registration charges and CMD amount again but get themselves re-register again.

The one time registration of the bidder is eligible to take part for the whole auction/sale process subject to lot wise payment of CMD

For participating in the auction, the prospective bidders should submit the following details/documents for Registration.

- e) PHOTOGRAPH WITH SIGNATURE OF EACH PARTNER/PROPRIETOR ON IT.
- f) ATTESTED COPY OF PARTNERSHIP DEED IN CASE OF PARTNERSHIP FIRM AND COPY OF MEMORANDUM (IN CASE OF COMPANY). RESIDENTIAL PROOF, MOTOR DRIVING LICENCE/AADHAR CARD/ TELEPHONE BILL OR ELECTRIC BILL, etc.

2. Caution Money Deposit :

Caution Money Deposit as per details mentioned in Annexure 'B' should be payable in the form of Bankers Pay Order/Demand Draft drawn in favour of **“Master (ADM), High Court, Bombay”** at the time of registration. It will be collected per Bidder. CASH WILL NOT BE ACCEPTED.

Note : The registered participant/bidders who have already paid aforesaid CMD amount with this office on for before 16.12.2022 as per previous schedule are not required to pay CMD amount again.

- a) The bidder will be able to participate in the E-auction of the particular batch/lot for which Caution Money Deposit (CMD) paid **(see Annexure B & C)**
- b) On receipt of CMD along with the **“REGISTRATION-cum-ACCEPTANCE Form”** as per **Annexure 'A'**. The Bidders must generate their unique **“User-Identity”** and **“Password”** during the online registrations, which is to be used for Actual Online Auction. Bidders SHOULD NOT disclose their User ID and Password to anyone and safeguard its secrecy. It is not possible to change the User ID OR the Password for the auction for which they have registered. Kindly note under no circumstances User ID and Password would be given over the telephone OR any other email address.
- c) The Caution Money Deposit (CMD) paid before the start of the auction within the specified period is adjustable in the EMD payments when the batch/lot is allotted to the highest successful bidder. The Caution Money Deposit of the unsuccessful bidders will be returned in **seven working days** after the closure of the auction by the seller.

Highest/Successful bidder has to pay within **3 working days** the EMD (33.33% of sale Amount) Failing to pay the required Earnest Money full CMD amount deposited will be forfeited. Bidders are expected to make the EMD payment, if they are the highest/successful bidder.

3. BID PRICE :

The minimum bid price will be displayed against each batch/lot on the bidding screen of all participating bidders. The software will be not accept any bid lower than the minimum bid price. The bidder may offer prices in the predefined multiples not less than Incremental value mentioned in Annexure -B (All communication shall be by email only. No postal/courier communication shall be forwarded, which may please be noted).

4. BATCH/LOT CONFIRMATION-EMD AND BALANCE PAYMENTS.

- a) The highest bid will be taken only on Subject to Confirmation (STC) basis. After the closure of the auction the batch/lot which are Accepted by The seller as '**Confirmed Acceptance**' will be intimated to the successful /highest bidder, by The Registry of High Court at Bombay only through e-mail.
- b) Within **Three working days** from the date of intimation of such confirmed acceptance, the highest/successful bidder has to pay an amount equivalent to 33.33% (Thirty Three Point Thirty Three Percent) of his bid amount less the Caution Money Deposit (CMD) deposited earlier i.e. upto as per office timings in the Car Cell Department of the seller during payment hours on any working days. This amount will be adjusted towards last installment of payment.
- c) The intimation of Confirmed Acceptance of Bid will be issued only in the name of the Bidder as is recorded in the registration form. Any further correspondence will be only with the Bidders on his name and address as recorded in the registration form.

- d) The highest successful bidder has to pay the Earnest Money Deposit (EMD) by way of Demand Draft/Pay Order only drawn on any Schedule Nationalized Bank drawn in the favour of “**Master (ADM), High Court, Bombay**” payable at Mumbai. If no intimation reaches for reasons beyond our control the Bidders are expected to take efforts to find out status before the last day. It is explicitly made clear that non-receipts of Intimation should not be an excuse for non-payment and CMD will be forfeited, if the highest /successful bidder fails to pay the required EMD before due date.
- e) After intimation of the Confirmed Acceptance the successful bidder has to deposit the **balance 66.67%** money by way of Pay Order/ Demand Draft only drawn on any Schedule/Nationalized Bank drawn in favour of “**Master (ADM), High Court, Bombay**” payable at Mumbai within **Ten (10)** working days from the date of intimation of such Confirmed Acceptance from Accounts Office of this Registry during payment hours on any working day.

5. **GST :**

CGST + SGST or any other levies as applicable will be payable extra by the successful bidder, in addition to the accepted bid value before taking delivery of vehicle.

Waste oil will be sold to the actual holding C.P.C.B valid Consent and M.P.C.B valid Consent.

6. The Registry of High Court at Bombay, Mumbai shall not be held responsible for any failure of power, server, hosting server, internet connectivity, ISP or otherwise at Bidder’s end directly or indirectly affecting Online method of Bidding.
7. Intending purchasers can inspect the vehicle in advance on site all vehicles will be available at sites for inspection on 03/01/2023 and 04/01/2023 between 10.00 a.m. to 6.00 p.m. on the said days.
8. Bidders will be allowed to bid for Lot for which Caution Money Deposit is paid.

9. Bidders succeeding in the auction are expected to lift the scrap in serial order of the list and continuously in consultation with consultation with concerned department of The Registrar, Original Side, High Court, Bombay on working days without break and with minimum time loss. The scrap will be handed over in presence of staff of concerned department.

10. Vehicle must be removed within 15 days from the date of acceptance letter given to the purchaser of lifting the vehicle by the respective staff of store/ location.

11. PAYMENT TERMS :

- (a) Earnest Money Deposit of 33.33% of the value of lot is to be paid within the stipulated time. E.M.D. will be accepted in D.D. or Pay Order favouring “**Master (ADM), High Court, Bombay**” payable at Mumbai. This amount will be adjusted towards the last installment of payment.
- (b) In case if the purchaser fails to pay the balance of sale value within the stipulated period as specified the Seller may agree to extend the period of making the balance payment which shall be not more than 30 days of the specified period mentioned above and charge interest at the rate of 2% per month or part thereof on the out standing amount notwithstanding the facilities given as above.
- (c) The Purchaser should note that the delivery memo will be issued to the successful purchaser after receipt of full/final installment.
- (d) In the event of the failure of the purchaser to pay the balance sale value of bid as mentioned in the contract will automatically stand terminated and the E.M.D will stand forfeited for the breach of contract by purchaser. The batch/lot in question will be resold by the Seller without any further reference to the purchaser.

12. DESCRIPTION OF VEHICLE QUALITY/QUANTITY :

- (a) The vehicle shall be disposed of on “AS IS WHERE IS BASIS”. And on “NO COMPLAINT BASIS”
- (b) Numbers, quantities or tonnage or nature of vehicle given in the catalogue are approximate and the vehicle will be sold without any regards or consideration of these number/tonnage or nature of

vehicle s and no warranty or guarantee shall be implied.

- (c) Description given in enclosed list is brief. Offers from the bidders will be deemed to have been made on the clear understanding that the intending bidder(s) have satisfied themselves fully in regards to the nature, condition, quality and quantity of goods upon inspection or otherwise. No error, commission or misstatement or misdescription whatsoever and howsoever made or published whether in advertisement or list or otherwise and not defects or faults in the goods shall invalidate the contract or be subject of any claim on the part of the bidder whether compensation or otherwise howsoever nor will any claim be entertained by the Seller.
- (d) The Seller shall be under no obligation to put the batch/lot singly or serially or in any particular manner and the Seller reserves the right at its discretion to withdraw batch/lot at any time during the period of auction without assigning any reason thereof. The Seller may refuse to accept any bid from any person/persons without any assigning any reason for the refusal.
- (e) If any non-ferrous metal is found in any of the ferrous batch/lot while effecting delivery the same shall be treated as the Seller property except where such non-ferrous metal are specially mentioned. The Purchaser shall not lift from any batch/lot any such pieces containing any non-ferrous metal and shall have no claim to the same or ask for any compensation on account thereof.
The Seller reserves the right not to sell any piece(s) from the vehicle mentioned in the bill of quantities which in the opinion of the Seller is useful for Department works and such vehicle if found will have to be kept aside and exclude from the sale as directed.
- (f) If on account of any unavoidable circumstances, vehicle at the above mentioned place could not be sold, no claim for compensation of any kind will be considered irrespective of quantity issued.
- (g) INSPECTION
Vehicles are sold on “AS IS WHERE IS BASIS AND WHATEVER IT IS” and on “NO COMPLAINT BASIS”. Quantities, qualities, sizes, measurements, numbers and weights whether displayed on the system, at the time of Online Auction Sale or specified in the catalogue are sold on the assumption that the bidder have inspected the same and known what they are buying. The principle of Caveat emptor will apply. The Seller do

not give any guarantee or warranty or undertake any responsibility for the make, manufacture, description, quantity, quality, condition size, weight, grade, accuracy, soundness, completeness, etc. of the vehicles mentioned in the catalogue or displayed in the system. The batch/lot shall be removed in full form the site with all faults and flaws in description or otherwise and no selection or sorting of the vehicle will be allowed. No complaint will be entertained after the batch/lot is knocked down.

All bidders/purchasers shall be deemed to have read and acquainted themselves with these conditions of sale and agreed to bid subject to these conditions only.

No sale shall be invalidated by reason of any defect or default in any of the batch/lot being inadequately described and no compensation shall be paid in respect of such default or deficiency of description.

13 REMOVAL OF VEHICLES :

- (a) Lifting of vehicle will be allowed with prior appointment during working days only between 11.00 a.m. to 4.00 p.m. except on 2nd and 4th Saturdays Sundays or Public Holidays, and that to in the presence of staff of department *concerned i.e. Car Cell Department*.
The Purchaser will not be allowed to lift the vehicle beyond working hours.
- (b) The Seller reserves the right to unload the vehicles for inspection purpose. If it is suspected at any time that the purchaser has loaded the vehicle(s) for which he is not the Purchaser or if the Purchaser is found to carry excess scrap than that mentioned in the documents, the Seller will be within its right to detain the truck, unload the vehicle(s) at the cost and expenses of the Purchaser and terminate the contract forthwith and forfeit the EMD and claim such further losses and damages that may be caused to the Seller.
- (c) It shall be the responsibility of the Purchaser to see that he/his servants or agents finding any quality and kind of item that is covered by the contract and in the event he/his servants or agents finding any quality of or kind or scrap mixed with the scrap allotted to him he should forthwith bring it to the notice of the concerned staff and lift scrap only after segregation.
- (d) Normally, oxy-cutting/cutting of the vehicle will not be allowed. However, in case where it is found that without such facility the removal of the vehicle is not possible, such oxy-cutting/cutting may be considered on specific request depending upon merit of the case, at the sole discretion of

the Seller subject to safety precaution by the purchaser. In such cases, losses in weight will be on account of the Purchaser.

- (e) During the course of removal of the vehicle if any damage is caused to the Seller premises, installation or instruments the purchaser will be entirely held responsible to make good such losses and he is liable to recoup it at the earliest.
- (f) Loading/unloading will be carried out by the Purchaser at his own cost. *The purchaser shall employ all labour staff registered with the Mumbai Iron and Steel Labour Boards and with Railway Goods Clearing and Forwarding establishment Labour Board for Greater Mumbai, provide under Regulation of Maharashtra Act XXX of 1969, the Maharashtra Mathadi Hamal and other Manual Workers Act 1969.*
- (g) Fork-Lifts/Cranes/JCB if required will also be allowed to hired by the purchaser at this own costs. Non Availability of Fork-lifts/Crane labour will not be considered as a ground for late lifting of the vehicle .
- (h) The original purchaser if wish to take the delivery of the goods through an Agent or his representative through a letter of authority which shall be presented to Seller after approval of the Seller he can be allowed to take delivery of goods. Delivery by proxy will be at the bidder's sole risk and responsibility and no claim shall lie against the Seller on account of whatsoever, if the delivery is affected to the wrong person(s).

14 PENALTY FOR DELAY IN COLLECTION :

- (a) **If the purchaser does not lift the vehicle(s) on pre decided day and time of delivery, he/they shall be liable to pay penalty Rs.2,000/- for that day without prejudice to other conditions.**
- (b) In case if the purchaser fails to remove complete delivery of the goods sold or part thereof within stipulated period, he/they shall be liable to pay demurrage charge at 2% of the sale value of unremoved quantity per day. Notwithstanding the facilities given above the Seller reserves the right to forfeit the amount paid by the Purchaser without any further notice and goods will be resold as deemed fit to the seller.

15 DECISION AND JURISDICTION IN CASE OF DISPUTE :

- (a) In case of any dispute regarding the contract the decision of the Seller shall be final and binding on all concerned.

- (b) Only the appropriate court in Mumbai will have Jurisdiction to deal with any disputes arising out of contract.

16. RIGHT TO ACCEPTANCE/REJECTION OF OFFER

- (a) The Seller reserves the right to withdraw wholly or partially any of the items set for sale at any time during the period of contract without assigning any reason.
- (b) The Seller is not bound to accept the highest offer; also the seller reserves the right to reject any CONDITIONAL offers. All rights to reject the offer, Although it may the highest are reserved with the Seller.
- (c) The goods are sold subject to the reserve price fixed by the Seller. If there is any dispute to the last or the highest bid, the goods shall be put for the sale again and their decision shall be final and binding to all.

17. FORFEITURE OF EARNEST MONEY DEPOSIT :

In case of failure to comply any of the condition especially 11 of terms above 11(a) & 11(b) & 14 of Terms and Condition of Auction Sale, the Seller may at its discretion terminate the contract and forfeit the EMD/Purchase price as the case may be and sell the vehicles to any other buyer at defaulting buyer's risk and recover the deficit if any, from the defaulting buyer.

18. TERMINATION OF CONTRACT :

The Registry of High Court at Bombay, Mumbai reserves the right to terminate the contract any time by giving three days notice on the following grounds :

- (a) Unsatisfactory execution or performance of the contract by the Purchaser.
- (b) For improper behaviour of the Purchaser or breach of the terms and conditions of the contract.
- (c) Decision of the Seller to terminate the contract shall be final and binding and no claim for damages and compensation shall lie provided always that in the event of the Purchaser or his Agent or his servants committing or attempting to commit theft, fraud dishonestly or gross misbehaviour in connection with the subject matter of his contract or in any other connection whatsoever concerning the business of the Seller, the Seller will be entitled to terminate the contract forthwith and forfeit the EMD or Purchaser price at its sole discretion.

19. GENERAL :

- (a) All notices letters e-mails sent to the purchase shall be deemed to have been received by him/them on expiry of hours from the time of posting if the same are sent at the address given by the purchaser.
- (b) Resale will not be recognized and delivery order/gate passes will be made in the same of the actual successful purchaser only.
- (c) The Purchaser shall not be entitled to resale any batch/lot or part of a batch/lot while the vehicles are still lying within the premises of the Seller and no delivery would be effected by the Seller to any person other than the purchaser whose names are mentioned in the delivery order
- (d) The Seller in no way will be responsible for any accident, damage or injury to the Contractor's Purchaser's Workmen or equipment while on the Seller premises.
- (e) If the successful purchaser at any stage either neglects or is unable to take delivery of the vehicle for any reasons whatsoever/or the performance of the purchaser is unsatisfactory, the seller will have the right to terminate the contract and forfeit the EMD/Purchase price and claiming such further loses and damages that may have been caused to the seller to determine and declare at its sole discretion.
- (f) In the event of the purchaser failing to remove the vehicle s and/or to pay the balance price thereof, the Seller shall be free to sell the goods to any other person or persons and to recover from the original purchaser the amount by which the price at which the vehicle s is actually sold falls short of the price agreed by the original purchaser. This does not in any way affect the right of the Seller to forfeit the EMD as provided therein.
- (g) Any dispute between bidder and the Seller relating to the auction shall be decided at the time of the auction by the Sellers representatives duly authorized to take such decision on behalf of the Sellers. The decision on behalf of the Sellers. The decision so taken will be final and binding on all persons.
- (h) The Purchaser is also required to sign an agreement or to bid-sheet complete the sale according to the condition hereof and subscribe his signature on the bid-sheet against the lot knocked down to him. In the event of the purchaser failing to sign the agreement or bid-sheet, the goods may if the seller may think fit be put for sale again immediately and resold on account and at the risk of the defaulting purchaser who shall be responsible for the deficit if any, in the price and such deficit shall be debt due from the defaulting purchaser but he shall not be entitled to any

increase arising from such resale.

- (i) Any misbehaviour or misconduct of the Purchaser or his agent may be dealt with to file the Seller an offence as per the IPC to the competent authority

20. NON-DELIVERY :

- (a) Where goods are sold in batch/lot and not in numbers or units of weight in the event of the batch/lot being found to be deficient in quantity, quality, size, measurement, number and weight as stated in the catalogue, the purchaser shall have no claim as against the Seller for the refund of whole or any part of the purchase money, or for loss or profit, interest, damage or otherwise.
- (b) Whether vehicles are sold by weight or number and not on the basis of batch/lot and the Purchaser fails to obtain the delivery of the whole or the part of the stores sold, he shall not be entitled to make any claim, other than for proportionate refund of the value of the undelivered quantity. He shall not be entitled to claim any damages loss or profit, interest or compensation on any account.
- (c) Where goods are bulky and cannot be weighed then the quantity mentioned is approximate and the amount paid will be adjusted against the actual weight/quantity delivered which will be final.

21. STEPS FOR ACTUAL BIDDING PROCEDURE :

Registration of Bidders :

1. To participate in the e-bid submission, it is mandatory for the Bidders to make one time enrolment (register on website) on the e-Auction portal at www.eauction.gov.in **Bidders shall require Digital Signature Certificate (DSC) with Signing Certificates to participate in this e-Auction.**
The bidder shall have to set the parameters of his/her computers so that the DSC is operational.
2. E-Application for individual auction and uploading of scanned copies of documents. Intending bidders who have registered at the e-auction portal as mentioned above have to apply online against respective item(s) by filling up form that will be available at the concerned webpage and required scanned documents in PDF format need to be uploaded.
3. Submission of Hard Copy of CMD and Registration Charge at this officer as per schedule given in clause 2 : **Bidders should note that the original copy of the CMD and Registration Charge should match with the one uploaded online.**
4. Approval by authority : Scrutiny of documents and uploading of approved list of bidders in the NIC e-Auction portal and thereafter only these approved bidders will be able to participate in the online auction.
5. Live e-Auction – Bidding Methodology :
On the date of auction as mentioned in the Clause-I i.e. **05/01/2023** at **10.00 a.m to 04.00 p.m.** auction will start against the listed item(s). Approved applicants will be eligible to participate in the auction. At the beginning of e-Auction, a starting price for each item shall appear.

A NOTE OF CAUTION FOR THE BIDDERS

Bidders during the last minutes of e-auction may encounter certain unforeseen problems such as time-lag, heavy traffic, system/power failure at the user end etc.
