- The interested vendor should submit their price list in the prescribed Annexure - I attached and with full details of the items. The vendors shall submit photocopy of Pancard and GST Certificate respectively.
- The rate mentioned by the Vendors in quotations will be shown separately **(Inclusive of GST)**.
- The Vendor should clearly mention the Name of Organization/ Company, Address, Phone no and Email Id clearly on quotation.
- The date and time for opening of the quotations will be informed through notice and email. While opening of quotations, vendor is free to attend himself or depute an authorized representative. Authorised representative should be a decision making person.
- The quotations will be opened at the given date and time informed in the notice. Tender will be opened irrespective of attendance of single vendor also.
- The successful vendor will require to show online warranty of the Network product i.e Network Switch to the office at the time of installation of network.
- In the case of breakdown or any obstacle in functioning of the Network during warranty period, the vendor shall ensure that, the same is replaced within 48 hrs.
- The warranty period should be mentioned in the original bill.
- Any complaint received after quotations opening will not be entertained.
- The installation of LAN Point and Power Point work should be complete within 15 days of receiving of Work Order. If there is any default for installation of LAN Point and Power Point work within the prescribed time, the 5% Security Deposit will be deducted/lapsed.
- Payment will be made after passing of bill by Pay and Accounts Office.

- No payment shall made in advance nor any loan from any bank or financial institution shall be recommended on the basis of award of work.
