**TENDER NOTICE**

The High Court of Judicature at Bombay, Bench at Aurangabad invites sealed tenders (Technical & Financial) from authorized dealers for supply of **35 Licensed copies of Windows 10 Operating System (Upgradable) and 16 Licensed copies of latest version of MS-Office,** for the use at Bombay High Court, Bench at Aurangabad.

Details of the required items are provided at **Annexure–A.** For any technical queries, interested bidders may contact **Phone No. 0240-2993303, Extension No. 251,** during office hours (10:00 a.m. to 5:00 p.m.).

**General Terms & Conditions:**

[1] The sealed tenders should be addressed to “ The Registrar (Admn.), High Court of Bombay, Bench at Aurangabad, Jalna Road, N-3, Cidco, Chhatrapati Sambhajinagar – 431009”.

[2] The sealed tenders should be superscribed with “Tender for Operating System and Microsoft Office” and same must be submitted in the office of Registrar (Admn.) High Court of Bombay, Bench at Aurangabad, on or before 22/12/2025 by 5.00 p.m.

[3] Before filling the rates, the interested bidders shall ascertain the requirements and features of MS Office from the concerned branches. After verification, they shall fill in and submit the tender. No complaints regarding

specifications will be entertained thereafter. The L1 bidder(s) shall supply and install the MS Office as required by the concerned branches within the quoted rates. Failure to supply the MS Office as required will result in reject the tender and forfeiture of the bidder's EMD.

[4] The interested bidder shall submit photocopies of all required documents, Demand Drafts, Authorization Letter/Declaration of OEM, etc., in the **Technical Envelope**, arranged serially as per the details mentioned in **Annexure "B"**. The rates for **35 licensed copies of Windows 10 Operating System (Upgradable)** and **16 licensed copies of the latest version of MS Office** shall be submitted in a separate envelope titled "**Price Bid Envelope**", as specified in **Annexure "A"**. Only those financial (price) bids will be opened whose technical bids are found to be eligible.

[5] The bidders should submit a **Tender Fee for Rs.1800/- [non-refundable]** and EMD for **Rs.9000/-** by Demand Drafts of any Nationalized Bank drawn in favor of Registrar (Admin.), High Court of Bombay, Bench at Aurangabad, payable at Chhatrapati Sambhajinagar with the tender. The tender without Tender Fee and EMD Shall be summarily rejected.

[6] The bidder shall quote the prices as per the proforma given in Annexure "A", and the quoted rates shall remain valid for a period of 180 days from the date of submission of the tender.

[7] The selected vendor should supply required quantity of original, as per purchase order at the office of Registrar (Administration), High Court of Bombay, Bench at Aurangabad. No transportation or any other additional charges will be paid to the vendor.

[8] After the finalization of the tendering process, the order will be placed as and when the requirement arises, subject to financial limits and availability of budget. The quantity of Operating Systems and MS Office mentioned in the tender may vary during the validity period of 180 days.

[9] It shall be the responsibility of the successful bidder to supply & install currently manufactured, original software. An undertaking to this effect must be submitted along with the bid. In case any problem arises with the supplied software, the bidder shall replace it immediately at their own cost. Failure to do so will result in cancellation of the purchase order and forfeiture of the EMD

[10] **Warranty and Lifetime Support:** The Supplier shall provide lifetime support for all supplied software, which shall include:

10.1) Assistance with activation, reinstallation, and reconfiguration whenever required.

10.2) Technical support related to functionality, licensing, and compatibility. Upgrade assistance within the scope of Microsoft's lifecycle policy (e.g., Windows 10 to Windows 11, or equivalent version transitions).

10.3) Security patch and update advisory for the lifetime of the product.

10.4) "Lifetime Support" shall mean support for the entire lifecycle of the software, including post-warranty technical assistance, as long as the software is supported by Microsoft or remains in use by the High Court of Bombay, Bench at Aurangabad.

10.5) No additional cost shall be charged for support during the software's operational lifetime.

[11] The High Court reserves the right to negotiate the prices quoted in the bid to effect downward modification.

[12] The Successful bidder will be informed in writing the date, place and

time for negotiations/clarifications, through offline method, if required. Representatives conducting negotiations on behalf of the bidder must have a written authority to negotiate and conclude a contract.

[13] The Successful bidder shall confirm in writing his participation in negotiations and ability to adhere to its Financial Proposals within five (05) days of receiving the notice in accordance with relevant clauses.

[14] Placement of order shall be subject to availability of Budgetary grants and payment will be made after supply of the required quantity of the items and receipt of original Invoice/bill in triplicate, subject to availability of Budget and passing bill from Treasury.

[15] The Dealer should not be a party in any legal proceedings before the Hon'ble High Court of Bombay.

[16] Tenders received after due date, incomplete in any respect or not accompanied by required documents is liable to be rejected. Tender sent by Fax/ e-mail will also be liable for rejection. No any correspondence will be entertained in this regards after submission of tender.

[17] The selected Dealer/ Supplier should not indulge in corrupt or fraudulent practices during the execution of contract. In such case the Registrar (Administration) High Court of Bombay, Bench at Aurangabad, reserves the right to terminate the contract by giving due notice.

[18] The Registry reserves the right to split orders or award all items to the One Vendor or accept or reject any tender as also to verify, modify or change any of the terms and conditions without assigning any reason thereof.

[19] Decision of the Registry of High Court Bench Aurangabad, in respect of evaluation of bids and / or award of contract will be final and binding on the Dealer/ Supplier and cannot be challenged.

[20] The decision of the Evaluation Committee regarding the evaluation of the qualification criteria and commercial bids shall be final. No correspondence will be entertained outside the process of negotiation or discussion with the Committee of this Registry.

[Note: The High Court of Bombay, Bench at Aurangabad, reserves the right to waive any minor informality, non-conformity, or irregularity in the technical bid.]

[21] The High Court of Bombay, Bench at Aurangabad, reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of the contract, without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the reasons for such action by the Tendering Authority.

[22] Arbitration :- In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by High Court Registry. The arbitration shall be at Aurangabad and the Arbitrator shall give his award in accordance with “The Arbitration and Conciliation Act, 1996”. The decision of the Arbitrator shall be final and binding upon the parties.

[23] Legal dispute if any, shall be subject to the jurisdiction of Aurangabad Court in Maharashtra State only.
