High Court of Judicature at Bombay, Bench at Aurangabad invites sealed tenders from reputed Agencies/Suppliers for repair of old furniture articles as mentioned at Annexure "A".

GENERAL TERMS & CONDITIONS :

- 1) Interested bidders should visit and inspect the furniture as mentioned at Annexure "A" before submitting the tenders on any working day between 10.00 a.m. to 5.00 p.m. prior to last date of submission of tenders. Once the tender is submitted, no complaint regarding repair work will be entertained by this Registry.
- 2) The Sealed tender should be addressed to the Registrar (Admn.), High Court of Bombay, Bench at Aurangabad, Jalna Road, N-3, Cidco, Chhatrapati Sambhajanagar - 431009.
- 3) The sealed envelopes should be superscribed with "Tender for repair of furniture articles" and must be reached to this office of the Registrar (Admn.) High Court of Bombay, Bench at Aurangabad, on or before **03/02/2025 up to 5.00 pm.**
- 4) Statutory Levies : The bidders shall quote the amount for repair of all furnitures mentioned at Annexure "A", including GST, labour charges, all

required material, statutory levies if any, charges by State or Central Government etc.

5) The bidder should enclose **Shop Registration Certificate, PAN Card, GST and relevant documents** with the quotation.

6) The successful bidder shall complete the allotted repair work, by replacing good quality parts thereof within 30 days including Holidays from the date of receipt of work order, as per the requirement of this Registry.

7) The successful bidder shall complete the said allotted work with proper care, correctly and expressly without any excuse, by replacing good quality spare parts and other material thereof, as accepted by this Registry, failing which penalty so as decided by this Registry will be deducted from the payment of Tenderer.

8) The Successful bidder shall get approval the samples of spare parts like cushions, cloth, cane material, handles, wheels of chairs, hydraulic and other material, if any, before repairing of furniture. The repair work shall be subject to the approval of this Registry. In case it is found inferior or not in accordance with the approved samples, it will be rejected and the work will have to be re-repaired to the satisfaction of this Registry.

9) All repaired furniture shall be carrying at least **01 [One] year** Warranty/Guarantee against defects of Manufacturer/workmanship and poor quality of components. Accordingly the tenderers shall indicate clearly and exhaustively the mandatory warranty/guarantee offered by them/ by the

manufacturing/supplying firms, its duration.

10) Uptime guarantee :During the warranty/guarantee period the successful bidder will have to maintain the above furniture in good working condition. All the complaints will have to be attended by the successful bidder within 24 hours of the dispatch of a complaint to their office. An undertaking to that effect will have to be submitted by the successful bidder while submitting their Invoice.

11) The payment will be made after repair of furniture & receipt of Invoice/Bill with satisfactory report from the concerned Department, subject to availability of Budget and passing bill from the Treasury.

12) The Registrar (Administration), High Court of Bombay, Bench at Aurangabad reserves the right to split orders and / or accept or reject any quotation as also to vary, modify, revise or change any of the terms and conditions or cancel the tendering process at any stage without assigning any reason thereof.

13) The Decision of this Registry in respect of evaluation of bids and /or award of contract will be final and binding on the Dealer/Supplier which cannot be challenged.

14) Legal dispute, if any, shall be subject to the jurisdiction of Aurangabad Court, in Maharashtra State only.
