Selection Process - 2017

(Accelerated promotion for the post of Civil Judge, Senior Division (10%))

As per Rule 5(2)(b) of the Maharashtra Judicial Service Rules, 2008, the 10% of the post of Senior Civil Judges are to be filled by promotion strictly on the basis of merit through Limited Competitive Examination amongst the Civil Judges, Junior Division.

The Limited Competitive Examination shall carry 200 marks comprising of 100 multiple choice objective type questions. The duration of the competitive examination will be of 90 minutes. Each question shall carry 2 marks. For each wrong answer, one fourth of the assigned mark to that question (0.50) will be deducted as penalty.

The syllabus for the Limited Competitive Examination for the accelerated promotion of Civil Judges, Junior Division to the post of Senior Civil Judge under Rule 5(2)(b) of the Maharashtra Judicial Service Rules, 2008 is as under:-



INSTRUCTIONS TO JUDICIAL OFFICERS

A) GENERAL :-

1. The Judicial Officers shall bring the examination admit card (call letter) for the examination.
2. The Judicial Officers shall bring with them identification proof to prove their identity if examination admit card is lost or not brought.
3. The Judicial Officers shall be present for examination before 45 minutes of the scheduled time.
4. No Judicial Officers would be allowed entry in the examination hall after 11.00 a.m.
5. The process such as the identification of the Judicial Officers as per call letter, distribution of answer sheets and filling in the necessary details thereon by the Judicial Officers shall be done from 10.15 a.m. to 11.00 a.m.
6. Time for marking of answers will be 90 minutes only and the examination will start at 11.00 a.m. sharp.
7. No Judicial Officers would be allowed to leave the examination, on any count, during the duration of examination.
8. The Judicial Officers shall bring black ink ball pen with them for filling in all details in the answer sheet.
9. The Judicial Officers shall carefully fill in all the particulars, and sign the attendance sheet.
10. The Judicial Officers should not mention their names anywhere in the answer sheet.
11. Carrying, possessing, using and/or transferring any electronic device such as a Mobile phone/Pager in the examination hall is strictly prohibited.
12. If the Judicial Officers bring with them any book, notes or scribbled paper or speaks to or communicates with, any other Judicial Officer, by any mode, while the examination is going on or smuggles in or takes out the answer sheet attempted or unattempted, the Chief Conductor may, upon being informed by the Supervisor, instantly issue suitable order for necessary action including immediate expulsion from the examination hall.

13. Judicial Officers who disobey the instructions issued by the Supervisor or who are guilty of rude or disobedient behaviour are liable to be instantly expelled from the examination hall.
14. As regards unfair means adopted by the Judicial Officers at the examination, the decision of the High Court shall be binding.

B) QUESTION BOOKLET :-

15. The Question Booklet will contain 100 questions carrying 200 marks. All questions will carry equal marks.
16. Immediately after the commencement of the examination, the Judicial Officers shall check that the question booklet does not have any unprinted or torn or missing pages or items etc. If so, the Judicial Officers shall get it replaced by a complete question booklet.
17. Question booklet will not be replaced after marking of answers in the answer sheet.
18. The Judicial Officers should encode clearly the booklet series A,B,C,or D as the case may be and indicate the series of question booklet, by completely shadowing the appropriate circle by **black ink ball pen** in the appropriate place in the answer sheet.
19. If the Judicial Officers shadow the circle in the answer sheet which does not match the series of question booklet provided to them, no marks will be allotted to such answer sheet.
20. The Judicial Officers shall enter their roll number on the space provided therefor in question booklet.
21. The Judicial Officers shall mark the correct choices in the separate answer sheet provided for the same.
22. The Judicial Officers shall carefully peruse the instructions on the last page of the answer sheet.

24. **Penalty for wrong answers -**
There will be penalty for wrong answers marked by Judicial Officer.
- i) There are four alternatives for the answer to every question. For each question for which a wrong answer has been given by the Judicial Officer, **one fourth** of the marks assigned to that question (0.50) will be deducted as penalty.
 - ii) If the Judicial Officers give more than one answer, it will be treated as a wrong answer, even if one of the given answers happens to be correct and there will be same penalty as above to that question.
 - iii) If a question is left blank, i.e. no answer is given by the Judicial Officers, there will be no penalty for that question.

C) **ANSWER SHEET :-**

25. The Judicial Officers should use only black ink ball pen to shadow the circles in the answer sheet and filling in necessary details on the answer sheet and attendance sheet.
26. Judicial Officers should write their roll number, question booklet number, question booklet series, name of the examination and sign at the appropriate places provided in the answer sheet.
27. There are four alternatives for the answers to every question denoted by choices **a, b, c & d**. The Judicial Officers shall answer the question by completely **shadowing by black ink ball pen only** the circle against the most appropriate choice of answer.
28. The question once answered by shadowing the circle in the answer sheet shall not be erased/obliterated/scratched/scored out etc. The circles which are shadowed, for more than once, or after erasing / scratching / obliterating / scoring the earlier circle will not be evaluated and such an answer will be treated as a wrong answer.
29. **Specimen question :**

- a) Law of Property
 - b) Law of the land
 - c) Law of marriages
 - d) Personal law of parties

30. The answer sheet is carbonless OMR sheet. Answer sheet Part-II should not be separated till the conclusion of the examination.
31. The Judicial Officers are allowed to carry question booklet with them after conclusion of the examination. They should hand over the answer sheets to the Invigilator without fail. However answer sheet Part-II should be detached carefully from the answer sheet, at the appropriate place, before handing over answer sheet to the Invigilator. Judicial Officers are allowed to carry answer sheet Part- II with them.
