It is hereby informed to all the retired Judicial Officers (retired during 31.07.2023 to 30.06.2026) in the cadre of District Judge, Ad-hoc District Judge, and Senior Civil Judge, that the High Court of Bombay has commenced the Selection Process for filling up **04** temporary additional post of **District Judge**, from retired District Judges and **01** temporary additional post of **Civil Judge, Senior Division**, from retired Ad-hoc District Judges / Civil Judges, Senior Division under the scheme of 14<sup>th</sup> Finance Commission.

The retired Judicial Officers from the cadre of District Judge shall be considered for the post of District Judge whereas retired Judicial Officers from the cadre of Ad-hoc District Judge and Civil Judge, Senior Division, shall be considered for the post of Civil Judge, Senior Division.

The Judicial Officers retired during the period from 31.07.2023 to 30.06.2026, having no assignment after retirement shall be considered. The retired Judicial Officers who have taken voluntary retirement and those who are compulsorily retired or dismissed shall not be considered.

The applicant shall send the duly filled in prescribed proforma alongwith medical fitness certificate of Civil Hospital on or **before Friday, 24<sup>th</sup> July, 2026 by E-mail on address "[rgrp-bhc@bhc.gov.in](mailto:rgrp-bhc@bhc.gov.in)"** and simultaneously the original of prescribed proforma be sent by **speed post** to the Office of the Registrar General, High Court of Bombay, Fort, Mumbai 400 032.

The envelope containing willingness / information in prescribed proforma and medical fitness certificate should be superscribed with the words **"Application for the temporary post of DJ / SD (14<sup>th</sup> F. C.)"**.
