**Note:-**

- 1) Await detailed Notification of the postings, which will follow.
- 2) The Hon'ble the Chief Justice and Hon'ble Administrative Judges have been pleased to direct that all the officers under orders of Annual General Transfers should leave the charge of their present posting in consultation with the Principal District Judges of the respective stations, leave charge during vacation period in such a manner that after utilizing admissible joining period, normally they take charge at new station on the date of re-opening before office hours. This is necessary to ensure that on re-opening of Courts after vacation, all the Judicial Officers are functional at new station.
- 3) Courts reopen after vacation on 7<sup>th</sup> June, 2021.
- 4) The Judicial Officers who are under order of transfer are directed (a) to finish by judgments all cases in which hearing has already been concluded and (b) should endeavour to dispose of all part-heard cases before handing over charge.
- 5) (\*) Judicial Officers not due for transfer and who are transferred on their request are not entitled to Transfer Grants/ Allowances.
- 6) (#) The Judicial Officers who are transferred and posted as a) Presiding Officer, School Tribunal, b) Deputy Charity Commissioner, shall leave the charge in consultation with the High Court.
- 7) Judicial Officers who have been **retained at the same station** in Annual General Transfer – 2020 and who are at the same station **for four years and in excess of four years** on or before **30.06.2021** are to be considered as **Due** for the process of **Annual General Transfers of 2021**.
- 8) A link is provided in the Judicial Officers portal (on official website of Bombay High Court) in respect of transfer options to these Judicial Officers only.
- 9) These Judicial Officers shall submit the form online from 8 January 2021 to 20 January 2021 till 5.30 p.m. The link will be disabled thereafter.
- 10) The Principal District Judges / Principal Judges are requested to put their remarks and upload the same latest by 5.30 p.m. Of 31.01.2021. The link shall be disabled thereafter.
