The following condition shall be treated as part and parcel of the above Tender Document with effect from the date of publication of this Corrigendum.

Additional Security Amount:

In case the successful bidder is found to have quoted amount less then 20% of the estimated/tender value shall submit An additional security amount of **3% of the contract value**, in the form of an **unconditional and irrevocable Performance Bank Guarantee**

issued by any Nationalised Bank. This additional security must be submitted within **seven (07) days** from the date of opening of the financial bid or from the date of communication by this office via e-mail, whichever is earlier. Failure to submit the said Performance Bank Guarantee within the prescribed timeframe shall result in automatic rejection of the bidder's offer without further notice. The Registry reserves the right to award the contract to the next eligible bidder. No complaint, clarification, or representation will be entertained after the lapse of the stipulated time.
