- 2) The Quotations should reach on or before 8th December, 2017 by 12.00 noon with all details as required in sealed envelope by Post, Courier or personally. The quotations sent through email will not be accepted. The quotations will be opened on 8th December, 2017 at 1.00 p.m
- 3) The Quotations should specify rates separately for reflective hoardings and without reflective hoardings.
- 4) The rates quoted should be inclusive of taxes/duties, levies or other traveling / transportation charges, lodging and boarding and preparing and installation, of Hoarding/Board on the above sites.
- 5) The 50% Payment will be made, if required, in advance by NEFT and 50 % payment will be made by NEFT after completion of work subject to the satisfaction of the Court Receiver.
- 6) The Contractor should possess experience of preparing and installing Hoarding/Board. Preference will be given to a Contractor who possesses an experience in preparing and installing Hoarding/Board work of government organizations.
