1. The candidates shall submit following original documents alongwith the self-attested copies of 04 sets as per Clause 11 of the advertisement (Instructions to the candidates) as follows :
  - I. Certificate or proof of date of birth (Leaving/ Birth Certificate/ SSC Board Certificate).
  - II. Certificate of having passed the qualifying examination/degree.
  - III. Statement of marks obtained at the qualifying examination/degree.
  - IV. Certificate of Character certifying that he/she bears good moral character from **two respectable persons** whose names are mentioned in the application form (issued on or after publication of advertisement).
  - V. A caste certificate from such authority as may be prescribed by the Government, wherever applicable.
  - VI. Disability Certificate issued by the Civil Surgeon/Medical Superintendent of concerned District Government Hospital, if applicable.
  - VII. Declaration of Small Family as appended to the format of the application form, Form “A”.
2. The candidates shall submit original experience certificate (if not already submitted) of minimum 2 years of Family Counselling gained after acquiring a Master’s Degree in Social Work.
