## TERMS AND CONDITIONS OF TENDER

3. The intending offerers will have to submit their offers in a sealed or closed cover along with the Demand Draft or Pay Order for Rs.4,000/- (Rupees. Four Thousand Only) as Earnest Money Deposit, in favour of “Master (ADM), High Court, Bombay” payable in Mumbai for a Lot of Unusable Tyres and old discarded spare parts, for participating in bidding for sale and the said amount will be immediately returned to the respective bidders by the Additional Registrar, Original Side/ Additional Prothonotary and Senior Master, in the event their offers being not accepted.
4. The offer received after the stipulated date and time, will not be accepted or if inadequately accepted, will not be opened.
5. The intending offerers are required to remain present before the Additional Registrar, Original Side/ Additional Prothonotary and Senior Master on **6<sup>th</sup> July, 2023 at 4.00 p.m.** and they will be allowed to increase their offers in the bidding.

The successful offerer shall pay the balance amount of the offer price by way of Demand Draft or Pay Order in favour of “Master (ADM), High Court, Bombay” payable in Mumbai, within three working days from the date of confirmation of acceptance of bid, failing which Earnest Money Deposit shall stand forfeited.
