ABOUT MEDIATION CENTRE

The High Court Mediation Monitoring Sub-Committee, Aurangabad is having panel of trained Mediators for post-litigation cases of High Court of Bombay, Bench at Aurangabad. There is need of Counsellors also. Therefore, the High Court Mediation Monitoring Sub-Committee has decided to constitute a panel of 05 Counsellors for pre-litigation and post-litigation matters. This panel will provide psycho-social services to the litigants approaching the High Court of Bombay, Bench at Aurangabad in matrimonial disputes and other disputes. The panel will provide services to individuals and couples in distress and promote their overall emotional wellbeing.

THE JOB PROFILE IS AS FOLLOWS:

QUALIFICATIONS:

The candidate should have completed M.A. in Counselling/Clinical Psychology along with a 2 years' experience of working as a Counsellor. Preference will be given to those candidates who have additional qualifications such as having completed specialized courses in Couple and Family Therapy or demonstrating direct experience of working as a Couple/Family Therapist. Preference will also be given to candidates who have an experience of working in legal settings. Proficiency in English, Hindi and Marathi is preferred.

JOB RESPONSIBILITIES


1. This position will entail working with individuals, children and couples who are currently undergoing matrimonial disputes or any other disputes and pre-litigation matters at High Court of Bombay, Bench at Aurangabad. The Counsellor will provide individual, couples and family counselling and also be responsible for documentation of the work.
2. The Counsellor will be required to do counselling at the counselling rooms of High Court Mediation Monitoring Sub-Committee, Aurangabad or at any other place, subject to orders from the Hon'ble High Court of Bombay, Bench at Aurangabad or directions of the High Court Mediation Monitoring Sub-Committee, Aurangabad.
3. The Counsellor will also be responsible for conducting group counselling.
4. Documentation of the work conducted at Sub-Committee is expected.

5. **DURATION:**

The appointment for the post shall be on purely contractual basis for 1 year which may be renewed in the following year considering effective service of Counsellors. The panel of Counsellors will be revamped from time to time. The Counsellor (part-time) shall work for 3 hours and shall be called as and when the services are required.
