2. The Praecipes should be sent on **bhccourt24@gmail.com** only. **PHYSICAL PRAECIPES SHALL BE ACCEPTED ONLY FROM THOSE ADVOCATES WHO DO NOT HAVE THEIR EMAIL ADDRESS.**

3. The email praecipe **SHALL NOT BE WITH A COVERING LETTER OR AS AN ATTACHMENT.**

4. All email praecipes shall be necessarily addressed to all concerned parties. The dates will be assigned only to those praecipes where email is addressed to all concerned parties under "To". Do not send email to other recipients on "*cc or bcc.*"

5. Praeipie without these details will not be considered as properly submitted praecipe, and no cognizance thereof will be taken.
6. **The email praecipies received on working days, i.e., Monday to Friday between 9 am to 10.30 a.m. will be treated as praecipies for that day and only those will be referred to Court to assign dates, the rest will be deleted without further reference to Court.**
7. Upon perusal of the praecipies, the Court will grant dates by replying thereto.
8. Normally matters will be listed on the assigned date only if the office objections are cleared. Reasons for non-clearance of objections shall be stated in the praecipe seeking an urgent date.
9. Mentioning of the matter in the Court shall be permitted only in **exceptional circumstances when there is extreme urgency for production on the same day only at 10.30 a.m. Again, unless there is extreme urgency, no mentioning at 1.30 p.m., 2.30 p.m. or 4.30 p.m.**
10. As far as possible, matters will be taken as under :-
