IN MODIFICATION OF EARLIER NOTICE DATED 8TH JUNE 2024 IT IS HEREBY NOTIFIED for the information of the Advocates and the parties appearing in person **at the Principal Seat at Bombay** THAT the Division Bench presided over by the **Hon'ble Shri. Justice G. S. Kulkarni and the Hon'ble Shri. Justice Somasekhar Sundaresan** has issued the following directions w.e.f. 12th August, 2024 :

I.

Listing of cases would be as under :

Monday & Tuesday	Writ Petitions and References under Direct Tax Laws.
Wednesday	All Appeals under Direct Tax Laws. Chartered Accountant References
Thursday & Friday	i) Civil Writ Petitions relating to resettlement of project affected persons. ii) Civil Writ Petitions relating to the Land Acquisition Act, 1894 and all other matters relating to acquisition and requisition of properties.

Other Directions :

(i) No mentioning of matters for circulation is permitted. Only matters of extreme urgency which cannot wait, can be mentioned for circulation.

(ii) In regard to other matters which may not involve extreme urgency, the following procedure for circulation of matters shall be followed :

(iii) Advocates and Parties-in-Person are requested to submit one page typed praecipe (in proper font), to the Associate / Sheristadar of the Court strictly between 10.15 a.m. to 10.25 a.m. The seriatim praecipe should be in the following format :-

- I. The urgency ;
- II. Date of the Impugned Order ;
- III. Date of Filing of the Petition ;
- IV. The Week Day as per allocation.

[II]

(i) **Senior Advocates are requested not to mention for circulation.**

(ii) **A brief list of dates and propositions of not more than 1-2 pages appropriately, be prepared to “assist the Court”, irrespective of the nature and stage of the proceedings, along with page numbers and without fail be furnished by 3 p.m. on the day prior to the listing of the matter. It should be in normal font having one and half spacing. The Registry shall place a remark, if the same is not circulated.**

(iii) Non-Urgent matters shall not be circulated, which would be listed as per its turn.

(iv) Excepting the urgent matters priority for admission and final hearing shall be given to old matters.

(v) In regard to illegible and handwritten documents, legible / typed copies be circulated one day before the listing date.

(vi) English Translation of documents intended to be relied upon be kept ready to be handed over to the Court when the matter is called out.

(vii) Final Hearing Board will be called out after Admission Board is over.
