Offers are required to reach the office of the Court Receiver, High Court, Bombay, having office at the address mentioned herein below, on or before **11th September, 2026 by 5:00 p.m.** in separate sealed envelope for vehicles superscribed as offer for vehicles in Contempt Petition No. 21 of 2022 in Commercial Suit No. 235 of 2018 described in the Schedule – I to Schedule - V .

The offers so received will be considered by the Hon'ble Court on **18th September, 2026 at 3.00 p.m.** at the time of hearing the aforesaid matter. The offerors may remain present before the Hon'ble Court and may increase their offer, if they so desire.

3. A copy of terms and conditions of the sale of the said vehicles will be available at the site at the time of inspection as well as in the office of the Court Receiver, High Court, Bombay at the address mentioned herein below, upon payment of **Rs.100/-** in cash, which is non-refundable and non-adjustable in any manner.

4. The offer for sale of the vehicles by the highest bidder shall be subject to sanction of the Hon'ble High Court, Bombay and the offer will be finalized as per direction of the Hon'ble Court. The Hon'ble Bombay High Court is not bound to accept the highest or any other offer and may reject any offer without assigning any reason.
