**ORDER**

**No. SID/VM/27/2013/97 /2013**

**Bombay, the 21<sup>st</sup> of March, 2013.**

WHEREAS, a disciplinary proceeding against Shri A. R. Bhadke, 3<sup>rd</sup> Joint Civil Judge, Junior Division and Judicial Magistrate First Class, Pusad, Yavatmal is contemplated.

NOW, THEREFORE, the Hon'ble the Chief Justice and the Hon'ble Judges - the Disciplinary Authority - in exercise of the powers conferred by Sub Rule (1) (a) of Rule 4 of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979, hereby place the said Shri A. R. Bhadke under suspension with effect from the date of service of the order of suspension.

It is further ordered that during the period this order shall remain in force, the Head Quarter of Shri A.R. Bhadke shall be Yavatmal and Shri A. R. Bhadke shall not leave the Head Quarter without obtaining previous permission of the Principal District Judge, Yavatmal.

It is not permissible for Shri A. R. Bhadke to accept private employment or to do business while under suspension, in view of the provisions of Rule 16 of the Maharashtra Civil Services (Conduct) Rules 1979. If, while under suspension, he accepts private employment or

does business, he will be guilty of misconduct and will be liable to be dealt with accordingly. He is also liable in that case to forfeit his claim for subsistence allowance.

During the period of suspension, Shri A. R. Bhadké will be entitled to subsistence allowance and dearness allowance, in accordance with Rules applicable to him.
