All fresh first appeals will be automatically listed for admission after fourteen (14) days of filing on assigned days, subject to removal of office objections.

No mentioning is permitted for seeking urgent circulation / production of matters / adjournment. Advocates and parties in person to submit a praecipe for urgent circulation with the Associate / Court Sheristedar before 10:25 am by stating the required details as per the following instructions. As per the details stated in the praecipe, appropriate date will be assigned and circulation dates granted will be published by the end of the day on the official website of this Hon'ble Court.

Instructions for filing circulation note / praecipe :

The praecipe must contain the following details :

1. The date of filing;
2. Stage of the main case e.g. admitted or pre-admission;
3. The details of urgency and interim relief prayed, to be stated in maximum 4 lines ;
4. If pre-ponement of the date already fixed is sought, state the date already fixed ;
5. If the request is made to produce the papers of the matter on the same day, state the reason why the matter cannot wait till the next day.
