It is hereby informed to all the retired Judicial Officers (retired during 31.07.2020 to 30.06.2023) in the cadre of District Judge, Ad-hoc District Judge, and Senior Civil Judge, that the High Court of Bombay has commenced the Selection Process for filling up **12** temporary additional posts of **District Judge**, from retired District Judges and **2** temporary additional posts of **Senior Civil Judges**, from retired Ad-hoc District Judges / Senior Civil Judges.

The retired Judicial Officers from the cadre of District Judge shall be considered for the post of District Judge whereas retired Judicial Officers from the cadre of Ad-hoc District Judge and Senior Civil Judge shall be considered for the post of Senior Civil Judge.

The retired Judicial Officers not more than the age of 63 years as on 30.06.2023 having no assignment after retirement shall be considered. The retired Judicial Officers who have taken voluntary retirement and those who are compulsorily retired or dismissed shall not be considered.

Please find annexed herewith prescribed proforma at **Annexure 'Y'**. The applicant shall send the duly filled in prescribed proforma alongwith medical fitness certificate of Civil Hospital on or **before 25.08.2023 by E-mail on address "rgrp-bhc@bhc.gov.in"** and simultaneously the original of prescribed proforma be sent by **speed post** to the office of the Registrar General, High Court of Bombay, Fort, Mumbai, 400 032.

The envelope containing willingness / information in prescribed proforma and medical fitness certificate should be superscribed with the words "**Application for the temporary additional posts (for retired Judicial Officers) for the Courts established under the scheme of 14th Finance Commission.**"
