**AUCTION NOTICE**

The High Court of Judicature at Bombay, Bench at Aurangabad invites sealed quotations from Reputed Vendors for Auction of Electrical and Electronic articles and furniture articles mentioned at Annexure "A" & "B" on "**As is where is basis**". No Claim or dispute will be entertained in this regard after auction.

**TERMS AND CONDITIONS**

- 1) The sealed quotation must be superscribed as "Quotation for Auction of Old/Unused Electrical and Electronic (E-waste) & Furniture articles". It should be addressed to the Registrar (Admn.), High Court of Bombay, Bench at Aurangabad, Jalna road, N-3, Cidco, Chhatrapati Sambhajinagar. The Last date for submission of tender in prescribed format is **12/01/2026 before 5.00 P.M.**
- 2) The award for Electronic and Electrical articles (E-Waste) shall be made only to the H1 bidder who is duly registered with the Central Pollution Control Board (CPCB) or the respective State Pollution Control Board (SPCB) / Ministry of Environment, Forest and Climate Change (MoEF&CC) as an authorized Recycler or Dismantler. The bidder must possess adequate environmental and management facilities for the collection, disposal, and recycling of e-waste, in compliance with the E-Waste Management Rules framed under the Environment

(Protection) Act. The Registration Certificate shall remain valid for the entire duration of the tender process, in accordance with the terms and conditions of the tender notice. For Furniture articles, the auction shall be awarded to the eligible H1 bidder in accordance with the terms and conditions of the tender notice. If required, the Registry reserves the right to split the orders between E-waste articles and furniture articles.

- 3) Any quotation received after the prescribed date and time shall be summarily rejected.
- 4) The Scrap material will be sold in **as is where is condition**. No claim or dispute will be entertained in this regard after conclusion of auction.
- 5) The Bidder must not be black listed by Central/State Government, Corporations or Government undertakings. An Undertaking to that effect must be submitted by the Agency.
- 6) **BID SECURITY** : Each bidder shall be required to submit a declaration in lieu of bid security, as per Annexure-E. The High Court Registry reserves the right to reject any bid that is not accompanied by the aforesaid self-declaration in the prescribed format (Annexure-E) along with the quotation. The decision of the High Court Registry in this regard shall be final and binding on all bidders.
- 7) The old Scrap material is available for inspection on any working day between 3.00 p.m. to 5.00 p.m. prior to last date of submission of tenders. Once the tender is submitted, no complaint of any nature regarding Scrap material will

be entertained by this Registry.

- 8) All the articles will be auctioned in one lot to the successful bidder and no partial bid shall be entertained.
- 9) The award of Auction/The items shall be sold to the bidder whose offer will be the affordable highest price. However, if the quoted rate of the H1 bidder is lower than the Upset Value fixed by the PW Department, the tendering process shall be cancelled.
- 10) The items once sold to the successful bidder shall not be taken back on any condition whatsoever.
- 11) The successful bidder shall pay the entire amount so quoted, by demand Demand Draft within 24 hrs., in the office of the Registrar (Admn.) High Court of Bombay, Bench at Aurangabad and then proceed further for lifting the articles.
- 12) The Registry will issue work order in favour of successful bidder in respect of auction.
- 13) The Time limit for removal of the auctioned materials shall be 3 days from the date of issue of work order (including Holidays). The successful Agency is required to remove the auctioned articles at his/her own cost within 03 days of receipt of communication from the office, during office hours.
- 14) While lifting and carrying the articles from the High Court premises care

shall be taken that no nuisance is created in the premises of the Hon'ble High Court.

15) The contractor/Agency shall be responsible for taking all necessary permissions from the competent authority of High Court Bench at Aurangabad.

16) Delivery, freight and all other charges shall be borne by the bidder and no separate payment shall be made on this account.

17) All materials/articles shall be removed from site by the agency at its own cost. The cost on this account shall be deemed to be included in the quoted offer.

18) Any damage caused by the workmen of the contractor to wall, ceiling, floors and fixtures etc should be made good at the contractor's cost.

19) The undersigned reserves the right to accept or reject any/all quotations, that too, without assigning any reason whatsoever and also cancel the tendering process, Spit the orders, adjourn or cancel or modify the terms of auction with or without notice and will not be liable for any loss or inconvenience caused to anyone in this regard.

20) The decision of the High Court Registry in the qualification criteria and selection of bidder shall be final and binding on participated bidders. No correspondence will be entertained outside the process of negotiation / discussion with the High Court Registry.

21) The High Court of Bombay Bench at Aurangabad reserves the right to cancel the tendering process at any stage, split orders and to annul the Bidding process and reject all Bids at any time, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.

**22) Arbitration :-** In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by High Court Registry. The arbitration shall be at Aurangabad in Maharashtra and the Arbitrator shall give his award in accordance with "The Arbitration and Conciliation Act, 1996". The decision of the arbitrator shall be final and binding upon the parties.

**23 ) Legal Jurisdiction :-**

All Legal disputes are subject to the Jurisdiction of Aurangabad Court in Maharashtra State only.
