SECTION OF BOMBAY DIGITAL LAW REPORT TO BE PUBLISHED  
BY THE BOMBAY HIGH COURT**

**Recruitment on Contract Basis**

Applications are invited from the eligible candidates for 01 post of Chief Editor, 2 posts of Editor (1 each for English and Marathi language), 4 posts of Deputy Editor and 5 posts of Assistant Editor at Bombay High Court on contract basis for the period of **for one year (12 months) from the date of actual contract. The Selected candidates will be paid a fixed/ consolidated remuneration and will not be entitled to any other Pay or Allowances and shall not be treated or deemed to be in regular employment of the Bombay High Court. It is a full-time assignment and the candidates will not be allowed to take up any other assignment during the period of the contract.** The appointment may be extended as per then existing requirement of the High Court. The candidates to be appointed for the aforesaid posts shall work as per the directions issued by the Hon'ble AI Assisted Legal Translation Committee of the Bombay High Court from time to time.

The last date for submission of the online application shall be **6<sup>th</sup> December, 2025 till 5.00 pm.**

***Note: - The application submitted by Speed Post only will be accepted. Any application submitted through email or by hand or any other mode will be disqualified.***

### **[B] General Criteria :-**

- (1) **The candidates must possess certificate about computer proficiency obtained from any of the following institutions:**
  - (a) Universities established under the Maharashtra Universities Act, 1994
  - (b) Goa/Maharashtra State Board of Technical Education
  - (c) NIC
  - (d) DOEACC
  - (e) APTECH
  - (f) NIIT
  - (g) C-DAC

(h) DATAPRO

(i) SSI

(j) BOSTON

(k) CREDIT

(l) MS-CIT or any other equivalent certificate issued by the Government recognized institute.

(2) The candidate must possess minimum skills to perform work for the post using computers and technology deployed for publication and search portal.

(3) The candidates must have sufficient knowledge of English as well as Marathi language to enable him to read, write and speak and translate from English into Marathi and vice versa.

(4) As per the number of aspiring candidates, the Competent Authority may conduct the test of preparing headnotes of Judgments in English and/or Marathi and viva voce for the said posts.

**2.** The candidates holding grades shall provide grades converted into percentage from the concerned Educational Institutions.

**3.** The educational and other qualifications as well as experience acquired as on the date of publication of the advertisement shall be taken into consideration for eligibility and further selection.

**4.** The list of eligible candidates and the date of test/interview will be published on the official website of the Bombay High Court at <https://bombayhighcourt.nic.in>.

**5.** At the time of interview, the eligible candidates shall submit two passport size photographs and the copies of Original Documents along with duly attested photocopies of the documents thereof as mentioned in the online application

and proof regarding conversion of grades into percentage, if applicable, for verification etc.

**6.** High Court may verify the documents submitted by the candidate from issuing authority.

### **Roles and Responsibilities**

#### **A) Chief Editor**

**1)** The Chief Editor shall ascertain the Judgments to be reported in the BDLR and allocate the same amongst the Editors, Deputy Editors and Assistant Editors for preparing the headnotes. The Chief Editor shall verify, edit and approve the Headnotes prepared by the Editors, Deputy Editors and Assistant Editors. The Chief Editor shall decide the chronology of Judgments to be published every month.

**2)** The Central Project Coordinator / Registrar with the prior approval of the Hon'ble Registrar General may prescribe the duties of the Chief Editor by general or special order, from time to time and likewise, may provide for the subordination of, and internal relativity among the staff of Bombay High Court and its Benches at Nagpur and Aurangabad.

**3)** The High Court may further specify, modify, add to or delete from the duties of the Chief Editor from time to time.

#### **B) Editor (Marathi)**

**1)** The Editor (Marathi) shall prepare the Headnotes of the Judgments in Marathi and shall also verify and edit the Headnotes prepared by the Deputy Editors and Assistant Editors. The Editor shall submit the verified headnotes to the Chief Editor for publishing the same.

**2)** The Central Project Coordinator / Registrar with the prior approval of the Hon'ble Registrar General may prescribe the duties of the Editor by general or special order, from time to time. and likewise, may provide for the subordination of, and internal relativity among the staff of Bombay High Court and its Benches at Nagpur and Aurangabad.

**3)** The High Court may further specify, modify, add to or delete from the duties of the Editor from time to time.

### **C) Editor (English)**

**1)** The Editor (English) shall prepare the Headnotes of the Judgments in English and shall also verify and edit the Headnotes prepared by the Deputy Editors and Assistant Editors. The Editor shall submit the verified headnotes to the Chief Editor for publishing the same.

**2)** The Central Project Coordinator / Registrar with the prior approval of the Hon'ble Registrar General may prescribe the duties of the Editor by general or special order, from time to time. and likewise, may provide for the subordination of, and internal relativity among the staff of Bombay High Court and its Benches at Nagpur and Aurangabad.

**3)** The High Court may further specify, modify, add to or delete from the duties of the Editor from time to time.

### **D) Deputy Editor**

**1)** The Deputy Editor shall assist Editor and handle responsibilities as per directions of the Editor.

**2)** The Central Project Coordinator / Registrar with the prior approval of the Hon'ble Registrar General may prescribe the duties of the Deputy Editor by general or special order, from time to time. and likewise, may provide for the subordination of, and internal relativity among the staff of Bombay High Court and its Benches at Nagpur and Aurangabad.

**3) The High Court may further specify, modify, add to or delete from the duties of the Deputy Editor from time to time.**

**e) Assistant Editor**

**1) The Assistant Editor shall prepare the Headnotes of the Judgments. The Assistant Editor shall submit the headnotes to the Deputy Editor (Marathi/English) for verification.**

**2) The Central Project Coordinator / Registrar with the prior approval of the Hon'ble Registrar General may prescribe the duties of the Deputy Editor by general or special order, from time to time. and likewise, may provide for the subordination of, and internal relativity among the staff of Bombay High Court and its Benches at Nagpur and Aurangabad.**

**3) The High Court may further specify, modify, add to or delete from the duties of the Deputy Editor from time to time.**

**Other Terms and Conditions**

**• Disqualification for appointment: -**

No person shall be eligible for appointment as Chief Editor, Editor, Deputy Editor and Assistant Editor : -

(a) if he is not a citizen of India.

(b) if he has been convicted of an offence involving moral turpitude, or he is or has been permanently debarred or disqualified by the High Court or the Union Public Service Commission or any State Public Service Commission from appearing for examinations or selections conducted by it; or

(c) if he directly or indirectly influences the 'Selection Committee' by any means for his candidature; or

(d) if he is a man, has more than one wife living and if a woman has married a man already having another wife: or

(e) if he has more than two children.

Explanation - For the purpose of this clause, where a couple has only one child, any number of children born out of a single subsequent delivery shall be deemed to be one child.

- **Condition relating to suitability, fitness, and Character: -**

No person selected by the Selection Committee shall be appointed: -

(I) unless the Appointing Authority is satisfied that he is of good character and is in all respects suitable for appointment to the service.

- **Tenure: -**

(i) All appointments to the posts of Chief Editor, Editor, Deputy Editor and Assistant Editor shall be on a contract basis.

(ii) The Chief Editor, Editor, Deputy Editor and Assistant Editor may be appointed for a period of one year and it may be extended.

- **Remuneration: -**

Remuneration shall be as per orders prescribed from time to time.

- **Termination: -**

1) The Appointing Authority may terminate the services of Chief Editor, Editor, Deputy Editor and Assistant Editor at any time and without assigning any reason, with one month's notice or one month's pay in lieu thereof and upon such termination the Chief Editor, Editor, Deputy Editor and Assistant Editor shall immediately cease to hold such office.

2) The Chief Editor, Editor, Deputy Editor and Assistant Editor may also seek termination of service with one month's notice or by depositing one month's pay in lieu thereof.

- **Transfer: -**

1) The posts of Chief Editor, Editor, Deputy Editor and Assistant Editor shall be transferable in between Principal Seat of Bombay High Court and its Benches.

2) The appointing authority shall have the prerogative to transfer Chief Editor, Editor, Deputy Editor and Assistant Editor at any time / at any location (i.e. Principal Seat of Bombay High Court and its Benches).

- **Training: -**

Every person appointed as a Chief Editor, Editor, Deputy Editor and Assistant Editor shall undergo such training as may be prescribed by the High Court from time to time.

- **Leave of absence : -**

The Chief Editor, Editor, Deputy Editor and Assistant Editor shall be entitled to such leave of absence as may be approved by the Member-Secretary, AI Assisted Legal Translation Committee, High Court at Bombay, subject to a maximum of eight days in a calendar year.

- **Residuary Provision: -**

The condition of the service of the Chief Editor, Editor, Deputy Editor and Assistant Editor for which no express provision is made shall be determined by the Committee of Judges of the Bombay High Court constituted by the Chief Justice of Bombay High Court, for such purpose when need arises.
