**NOTIFICATION BY THE HIGH COURT OF JUDICATURE

The Honourable the Chief Justice and Judges hereby direct that the Judicial Officers mentioned below, serving/retired having completed three years of service and having satisfied all other conditions laid down in Government Resolution, General Administration Department, No. SRV- 1075-X, dated the 19th September, 1975 and guidelines framed in the Administrative Judges' Meeting dated 7th May 1992, be deemed to be permanent Government Servants in the post of Civil Judge, Junior Division and Judicial Magistrate, First Class only for the purposes of admissibility of pensionary benefits and leave, irrespective of the available permanent post and their seniority in the cadre of Civil Judge Junior Division and Judicial Magistrate First Class :-
