2. **Orders on praecipe:-**

The Advocates or parties appearing in-person seeking extension of time to complete recording of evidence by commissioner/extension of time for removing office objections/extension of time to file affidavit in-reply, in- rejoinder etc., may apply by way of praecipe under notice to all concerned in the matter and also append their respective appearances with the said praecipes.
