IT IS HEREBY NOTIFIED for the information of the Advocates and the parties appearing in person that **the Hon'ble Shri Justice Kamal Khata (Court Room No. 16A)** has directed following allocation of days for the category of matters as per assignment.

In addition to the above following categories of matters will be taken up on specified days:

Monday to Friday	For admission / hearing and applications therein: Appeals from Order, from the year 2021 to 2024 (Appellate Side)
Monday	For admission / hearing and applications therein: (1) Writ Petitions not assigned to other Courts. (2) Writ Petitions under the Maharashtra Land Revenue Code and the Maharashtra Stamp Act.
Tuesday	For admission / hearing and applications therein: (1) Suits and commercial suits from the year 2015 to 2020 2) Matters under Parsi Marriage and Divorce Act and Other Matrimonial Suits and Matters arising therein.
Wednesday	For admission / hearing and applications therein. (1) Testamentary Matters, from the year 2011 to 2020.
Thursday	For admission / hearing and applications therein. (1) Matters pertaining to Land Acquisition references and Land acquisition Act (Original Side) (2) First Appeals relating to Land Acquisition, up to the year 2010 (Appellate Side)
Friday	For admission / hearing and applications therein (1) Matters under Section 34 of the Arbitration and Conciliation Act, 1996, of the year 2024 (Original Side). (2) Appeals from Order, from the year 2021 to 2024 (Appellate side)

IT IS FURTHER HEREBY NOTIFIED for the information of the Advocates and the parties appearing in person at the Principal Seat at Bombay that the Single Bench presided over by the Hon'ble Shri Justice Kamal Khata has issued the following directions :-

1. All suits, petitions, or applications (with lodging or stamp numbers) will be listed in court on the 7th working day after office objections are cleared and a final number is given under the caption of fresh Admission.
2. No praecipe for urgent listing will be accepted on lodging or stamp number.
3. Praecipe for matters which are finally numbered will be accepted between 10.30 a.m. and 11.00 a.m.
4. Advocates and parties appearing in person, who are desirous of having the matter listed for urgent hearing or seeking change of date, may file a joint praecipe signed by both parties or, in the alternative, file a praecipe with due notice to the opposite party.
5. If a matter is very urgent and cannot wait till its next scheduled hearing, it may be placed on the Production Board subject to notice to the other side. In that case submit a praecipe to the court Associate before 10:50 a.m. The praecipe must clearly explain urgency. If the court doesn't find it urgent enough, it will not be listed.
6. Appearances must be typed (not handwritten) and should include the serial number, case number and date, name of the advocate, for whom (Plaintiff/ Petitioner/ Respondent/ Defendant) they are appearing. Handwritten appearances will not be accepted. If appearance is handwritten, it shall be in strictly written in Capital Letters (Uppercase), further, any corrections or clarifications (speaking to the minutes) will not be entertained.
