Sealed Quotations are invited from reputed registered Book Publishers/ Distributors/Vendors/ Suppliers for supply of books.

Sealed envelopes must be superscribed with “*Quotation for Empanelment for supply of Library books to Judges' Library for the period of two years i.e. 2026-27 & 2027-28*”.

Interested book publishers/ distributors/ vendors/suppliers dealing with supply of *Law Books (both Indian and Foreign - Standard Publications), Central and Maharashtra State Bare Acts, General reading books in Marathi, Hindi and English* may submit their quotations to “*The I/c Deputy Registrar, Library, Museum, Legal research and publication, Room no.1, Ground floor, Main building, High Court of Bombay, Mumbai- 400032*”. Sealed quotations should reach the undersigned by Hand delivery/Speed/Regd. Post/Courier on or before **2nd September 2026 up to 5.00 PM**. Quotations which are received thereafter, will not be entertained and considered at all.

Important Instructions

- The sealed envelopes must be superscribed with “*Quotation for Empanelment for supply of Library books to Judges’ Library at Mumbai for the period of two years i.e. 2026-27 & 2027-28*” with name and address of the vendors.
- The application should be signed by an authorised signatory of the vendor(s) bearing his/her full name and position, below the signature along with the official seal of the firm.
- Incomplete and conditional applications will not be considered.
- At any given point of time, if any of the documents furnished by the vendors/suppliers is found to be false, it would be deemed to be breach of terms of contract making the firm concerned liable for legal action besides termination of empanelment.
- Strict discipline is expected to be maintained with respect to application for empanelment. No canvassing or repeated communication shall be entertained by the library. Failing to maintain this discipline, the applicants are liable to be black-listed.
- **The applications received after the due date will not be considered.**
- The applications will be scrutinized and shortlisted for empanelment by the designated officers of the High Court of Bombay. The Honourable Judges’ of the Library Committee are the final authority for empanelling the vendors for supply of library books. The selected vendors will be informed by email and/or regular post for further procedure.
- No publisher/ distributor/ vendor /supplier will be allowed to withdraw after submission of the quotation, failing to maintain this discipline the supplier may be blacklisted.
- The selected publishers/ distributors/ vendors /suppliers for empanelment are required to supply books as per the “Terms and Conditions for supply of books” as given hereunder.



Terms and Conditions

The empanelment for supply of books will be governed by the following terms and conditions

1. The High Court of Bombay reserves the right to change or modify or amend or substitute any clause(s) in the “Terms and Conditions”, if required at any time.
2. The High Court of Bombay reserves the right to empanel any vendor or to cancel the empanelment at any time, without giving any notice or reason there for.
3. Submission of the application does not confer any right on any applicants for empanelment with the High Court of Bombay.
4. The decision of the High Court of Bombay on all the matters connected with or incidental to empanelment shall be final and binding on all and shall not be called in question on any ground.
5. The vendor to whom the purchase order will be placed is required to offer best and prompt services.
6. ***The vendors may be required to supply the books in a short notice of 24 hours or lesser time as per the urgency of the High Court of Bombay.***
7. The purchase of books (print and electronic) for the High Court of Bombay will not be bulk purchase but regular purchase with limited number of copies as and when required throughout the year. ***The vendors will have to send the books on approval basis to the High Court of Bombay and to collect back the books which are not approved, at their own cost.***
8. The applicants should clearly mention the items for which they seek empanelment along **with maximum discount offered by them** for the purchase of Print / Electronic form of law books, bare acts, general books, etc. ***The maximum discount rate once offered by a vendor/publisher cannot be reduced during the period of empanelment.***

9. For supply of foreign books only authorised distributors/ agents of publishers/ distributors will be entertained for empanelment. GOC (Good Offices Committee) rate will be applicable.
10. The law book publishers can submit the application and make arrangements with their distributors located in Mumbai to supply their publication within the prescribed time limit.
11. The panel of vendors approved for particular publication will be valid for a period of two years.
