- 2) The rates quoted shall be inclusive of all taxes which shall be valid for period of one year.
- 3) The AMC Charges will not be increased by the vendor/agency during contract period in any case.
- 4) The dealers/vendors must have a Permanent Account Number (PAN) and must be paying Income Tax. The Photocopies of Shop Registration, PAN and GST etc. should be submitted along with quotation. The Registry reserves all rights as regards to the qualification criteria and verification of documents. No any outside

correspondence in this regard will be entertained by the Registry.

5) The payment will be made as per Government rule/procedure on quarter basis, after satisfactory service report received from the Court Keeper Branch of this Registry, subject to availability of budget and passing bill from the Treasury. In case the bidder breaches any of the Term & Condition or fails to provide satisfactory services immediately during the contract period, suitable penalty amount so decided by this Registry would be debited from the quarterly bill of successful agency.

6) The Contract of Intercom System (EPABX System) is subject to replacement of Intercom System (EPABX System) by this Registry, if such replacement is made, the office reserves the right to deduct the amount of such replacement, while making payment. The contract is liable to be terminated during the contract period, if the services of the firm is not up to the satisfaction of the competent Authority.
