AUCTION NOTICE**

The High Court of Judicature at Bombay, Bench at Aurangabad invites sealed tenders in two part bidding system (Technical and Financial) from “Registered e-waste Recyclers/Dismantlers” as per the provisions of E-Waste Management Rules under the Environment Protection Act for the **auction of unused/old Electrical and Electronic articles** on “As is where is basis”. No Claim or dispute will be entertained in this regard after auction. The details of above articles is at Annexure “A”.

TERMS AND CONDITIONS

1) The sealed Tender must be superscribed as "Tender for E-waste - Auction of Old/Unused Electrical and Electronic articles". It should be addressed to the Registrar (Admn.), High Court of Bombay, Bench at Aurangabad, Jalna road, N-3, Cidco, Chhatrapati Sambhajinagar. The Last date for submission of tender in prescribed format is **18/11/2024 before 5.00 P.M.**

2) The buyer should be registered with Central Pollution Control Board/State Pollution Control Board/Ministry of Environment and Forest, as authorized Recyclers/Dismantlers and having environmentally and management facilities for collection, disposal/recycling of e-waste., as per the provisions of E-waste

Management Rules under the Environment Protection Act., and the Registration Certificate must be valid till the completion of entire process, as per terms and conditions of tender notice.

3) PREPARATION OF BIDS: Bid Documents has to be submitted in TWO SEPARATE SEALED ENVELOPES (inside the master envelop) labelled as under: - I. Technical Bid (Envelop No. 1) II. Financial Bid (Envelop No. 2).

NOTE: The Technical bid and Financial bid must be enclosed in separate sealed envelopes inside the master envelop. The documents mentioned at Annexure- "B" should be contained in Bid submission: A. CONTENT OF TECHNICAL BID (ENVELOPE 1) Bidder should submit technical bid inside the sealed envelope labelled "Technical Bid"

4) CONTENT OF FINANCIAL BID (ENVELOPE 2) The Bidder should submit financial proposal inside the sealed envelope labelled "Financial Bid". Financial bid should be as specified in Annexure-C, printed on Company Letter head and Duly signed and with Company seal. All prices quoted in the Financial bid must be in Indian Rupee only and shall be fixed, firm and final. No commercial information shall be mentioned in the technical bid, failure to do so may lead to cancellation of the bid.

5) The Scrap material will be sold in **as is where is condition**. No claim or dispute will be entertained in this regard after conclusion of auction.

6) The Bidder must not be black listed by Central/State Government, Corporations or Government undertakings. An Undertaking to that effect must be

submitted by the Agency.

7) BID SECURITY : Each bidder will be required to submit a declaration against bid security as per Annexure-D. The High Court Registry reserves the right to reject any bid received without the above-mentioned self-declaration as per Annexure-D in the Technical bid. The decision of this Registry in this regard shall be final and binding on the bidders.

8) The old Scrap material is available for inspection on any working day between 3.00 p.m. to 5.00 p.m. prior to last date of submission of tenders. Once the tender is submitted, no complaint of any nature regarding Scrap material will be entertained by this Registry.

9) All the articles will be auctioned in one lot to the successful bidder and no partial bid shall be entertained.

10) The award of Auction/The items shall be sold to the bidder whose offer will be the the affordable highest price. If the quoted rates of H1 bidder is less than the Upset Value provided by the PW Department, it will be accepted if permitted by the State Government.

11) The items once sold to the successful bidder shall not be taken back on any condition whatsoever.

12) The successful bidder shall pay the entire amount so quoted, by demand Demand Draft within 24 hrs., in the office of the Registrar (Admn.) High Court of

Bombay, Bench at Aurangabad and then proceed further for lifting the articles.

13) The Registry will issue work order in favour of successful bidder in respect of auction.

14) The Time limit for removal of the auctioned materials shall be 3 days from the date of issue of work order (including Holidays). The successful Agency is required to remove the auctioned articles at his/her own cost within 03 days of receipt of communication from the office, during office hours.

15) While lifting and carrying the articles from the High Court premises care shall be taken that no nuisance is created in the premises of the Hon'ble High Court.

16) The contractor/Agency shall be responsible for taking all necessary permissions from the competent authority of High Court Bench at Aurangabad.

17) Delivery, freight and all other charges shall be borne by the bidder and no separate payment shall be made on this account.

19) All materials/articles shall be removed from site by the agency at its own cost. The cost on this account shall be deemed to be included in the quoted offer.

20) Any damage caused by the workmen of the contractor to wall, ceiling, floors and fixtures etc should be made good at the contractor's cost.

21) The undersigned reserves the right to accept or reject any/all quotations, that too, without assigning any reason whatsoever and also cancel the tendering process, adjourn or cancel or modify the terms of auction with or without notice and will not be liable for any loss or inconvenience caused to anyone in this regard.

22) The decision of the High Court Registry in the qualification criteria and selection of bidder shall be final and binding on participated bidders. No correspondence will be entertained outside the process of negotiation / discussion with the High Court Registry.

23) The High Court of Bombay Bench at Aurangabad reserves the right to cancel the tendering process at any stage, split orders and to annul the Bidding process and reject all Bids at any time, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.

24) Arbitration :- In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by High Court Registry. The arbitration shall be at Aurangabad in Maharashtra and the Arbitrator shall give his award in accordance with "The Arbitration and Conciliation Act, 1996". The decision of the arbitrator shall be final and binding upon the parties.

25) Legal Jurisdiction :-

All Legal disputes are subject to the Jurisdiction of Aurangabad Court in Maharashtra State only.
