IT IS HEREBY NOTIFIED for the information of the Advocates and the parties appearing in person at the Principal Seat at Bombay that the **Division Bench comprising of the Hon'ble Shri. Justice G.S. Kulkarni and Hon'ble Ms. Justice Aarti A. Sathe** have issued the following directions w.e.f. Monday, 2nd February, 2026 :

- (i) No mentioning of matters for circulation is permitted. Only matters of extreme urgency which cannot wait are permitted to be mentioned for circulation or production with advance notice to the Respondents/ its standing counsel/ Advocates.
- (ii) **Senior Advocates are requested not to mention for circulation.**
- (iii) In regard to non urgent matters, the office procedure for listing of these matters shall be followed.
- (iv) Advocates and Parties-In-Person are requested to submit one page typed praecipe (in proper font), to the Associate/ Sheristedar of the Court strictly **between 10.30 a.m. to 10.45 a.m.** The seriatim praecipe to be accepted shall be in following format:-

- I **Name of the Advocate.**
- II **Proceeding Number.**
- III **The cause of action and clear urgency;**
- IV **Date of Filing of the Petition;**
- V **Date of the Impugned Order;**
- VI. **Act**
- VII. **Subject wise assigned Day**

- (b) In respect of the matters which are notified on the cause list to be submitted before 3 p.m. on the earlier day. (For Monday listing by 3 p.m. on the earlier Friday)

A brief list of dates and propositions of not more than 1-2 pages appropriately, be prepared to “assist the Court”, irrespective of the nature and stage of the proceedings, along with page numbers, exhibit numbers etc. It should be in normal font (14pt) having one and half spacing. The Registry shall place a remark, if the same is not circulated.

* Note:- Non compliance of (i) would entail rejection of the praecipe.

- (ii) Excepting very urgent matters priority, for admission and final hearing shall be given to old matters.
- (iii) In regard to illegible and handwritten documents, legible / typed copies be circulated one day before the listing date.
- (iv) English Translation of documents intended to be relied upon be kept ready to be handed over to the Court when the matter is called out.
