IT IS HEREBY NOTIFIED for the information of the Advocates and the parties appearing in-person at the Principal Seat at Bombay that the Single Bench presided over by the Hon'ble Shri Justice Somasekhar Sundaresan has issued the following directions with immediate effect:

1. Non-Banking Financial Companies, and (rarely) banks i.e. lenders, often file ***Section 9 Petitions*** in connection with ***loan and facility agreements*** and ***connected documentation*** such as guarantees, deed of hypothecation / mortgage / other encumbrances containing arbitration clauses.
2. To enable efficient presentation and processing of such proceedings, Advocates and parties in person are required to bring a ***chart in the proforma*** set out in ***Annexure*** to this Notice.
