NOTICE INVITING QUOTATIONS

The High Court of Judicature at Bombay, Bench at Aurangabad invites sealed quotations from reputed Agencies/Suppliers/Manufacturers for supply of Steel Trolleys for the use of High Court of Bombay, Bench at Aurangabad. The details are as under :

Item Description	Required Qty. (Approx.)
<p style="text-align: center;">Stainless steel trolley</p> <p>shall be fabricated from SS pipe with overall dimensions of 2 ft height, 1.5 ft width, and 2 ft length, strictly as per the approved sample. The trolley shall be provided with a handle fixed at a height of not less than 9 cm above the trolley frame/platform, made from the same stainless steel material. The handle shall be securely welded, ergonomically positioned for easy handling, and finished smoothly without sharp edges. All dimensions, material quality, and workmanship shall be subject to inspection and approval by the purchaser before acceptance. The enclosed image is for reference to design and configuration only.</p>	24 Nos.

GENERAL TERMS & CONDITIONS :

1) The sample of Steel Trolley is available for inspection purpose in the Nazir Department of High Court of Bombay, Bench at Aurangabad, on any working day from 10.00 AM. to 5.00 PM. prior to the last date of submission of quotation.

- 2) The Sealed quotations should be addressed to the Registrar (Admn.) High Court Bench at Aurangabad, Jalna Road, Aurangabad - 431009.
- 3) The sealed Envelopes should be superscribed with "Quotation for supply of Steel Trolleys" and must be reached to this office of the Registrar (Admn.) High Court of Bombay, Bench at Aurangabad, on or before **13/01/2026 at 5.00 p.m.**
- 4) The prices quoted by the Vendor shall be in Indian currency and inclusive of all Levis, Taxes introduced by the Government, packaging and delivery charges etc. and not be subject to any price escalation.
- 5) The bidders should filled and submit Annexure 'A' and 'B' along with photocopies of **Shop Registration Certificate, PAN and relevant documents** with the quotation as mentioned at Annexure 'A'.
- 6) The L1 bidder shall arrange sample of Steel Trolley including the wheels as approved by this Registry, as per specifications/sample mentioned in the tender notice, at its own cost and risk before the Hon'ble Committee at High Court, Bench at Aurangabad for approval of sample. The bidders shall have to comply with such conditions, failing which, the tenderer shall be liable for rejection.
- 7) Placement of order, will be subject to satisfaction of the Registry about quality of the Steel Trolley, offered by the lowest tenderer and if the Registry is not satisfied of product being offered by the lowest tenderer, it reserves the right to place the order in favour of the next lowest tenderer, as the case may be, who offers good quality product.

8) The decision of the Hon'ble Committee in the approval of sample shall be final. No correspondence will be entertained outside the process of discussion with the High Court Registry.

9) The supplier is to be entirely responsible for the execution of the purchase order in all respects in accordance with the terms and conditions. The selected bidder will have to supply the required quantity of the Steel Trolleys, as per as per approved sample by this office at the office of the Registrar (Admn.), High Court of Bombay, Bench at Aurangabad.

10) The time for and the date of delivery of the Trolleys normally maximum 15 days from the date of issue of the purchase order. The tenderer shall deliver the Trolleys at the office of the Registrar [Admn.], High Court of Bombay, Bench at Aurangabad within the stipulated time.

11) After delivery of Trolleys or during the using period, if any defect is noticed in the Trolleys or supplied material quality is found poor or are not as per tender requirement/specifications/sample, the tenderer shall have to take the same [rejected store] back at his own cost and risk, and further shall replace such rejected trolleys as per sample/ as acceptable to the High Court Registry.

12) Payment will be made as per Government rule/procedure after successful successful execution of purchase order/specifications mentioned at Annexure "A", subject to availability of Budget and passing of bill from Treasury. However, it is provided that if there is a delay in making payment of the bill, then this Registry shall not be liable to any interest / charges to the bidder.

13) The Registry of the High Court Bench, Aurangabad reserves the right to split orders and annul the bidding process at any state/ or accept or reject any quotation as also to vary, modify, revise or change any of the terms and conditions without assigning any reason thereof.

14) Decision of the Registry of High Court Bench Aurangabad in respect of evaluation of bids and /or award of contract will be final and binding on the Dealer/Supplier which cannot be challenged.

15) Legal dispute, if any, shall be subject to the jurisdiction of Aurangabad Court, at Chhatrapati Sambhalingar.
