### **For List of Dates, Written Submissions and Authorities**

1. List of Dates, Written Submissions & Authorities (compilation), in the following manner;
  - a. List of Dates
  - b. Written submissions
  - c. Authorities
2. In PDF & Word format, in separate files (only PDF format for authorities)
3. Page Numbered in seriatim with Index, &, if possible, with a bookmark for each indexed item.
4. Name of the file shall be in the following format

X(number)- [position of the party ex. P/ A/ R] – LoD/ Ws/ Au – [Name of the First Petitioner/ Applicant v. Name of the first Respondent/ Defendant] - [Matter No.]

Ex.

  - 1-P–LoD–ABC v. EFG – WP No. 123 of 2025
  - 2-P–Ws–ABC v. EFG – WP No. 123 of 2025
  - 3-P–Au–ABC v. EFG – WP No. 123 of 2025
- b.
  - 1-R–LoD–ABC v. EFG – WP No. 123 of 2025
  - 2-R–Ws–ABC v. EFG – WP No. 123 of 2025
  - 3-R–Au–ABC v. EFG – WP No. 123 of 2025

5. The PDF & Word file shall be mailed at [jkkcod@gmail.com](mailto:jkkcod@gmail.com)
  - a. The body of mail shall have the matter number and the date assigned for hearing.
  
6. Unless otherwise directed by an order of the Hon'ble Court
  - a. The compilation, shall be served on the other-side, in advance, the other-side shall give their structured response to the same within a week.
  - b. LoD shall be consolidated/amalgamated by the parties.
  - c. Consolidated LoD shall be consolidated/amalgamated in a manner reflecting dates and events submitted by both the parties, same date may have two different versions of events, listed one after the other, with a mark indicating which party has submitted the event, where ever there are multiple events.
  - d. The LoD, written submissions shall have references to page numbers in pleadings, authorities shall have ratio and paragraphs mentioned.
  
7. The response shall also be e-mailed to the above said mail-id, 3 days in advance of the assigned date of hearing.
  
8. Hard Copies of the compilation and response shall be filed in registry, before the assigned date of hearing.
