IT IS HEREBY NOTIFIED FOR THE INFORMATION OF THE Advocates that, applications/ proposals are invited for creation of a dedicated pool of "Amicus Curiae" to assist the Courts in old Criminal Appeals as per the directions of the Hon'ble Supreme Court of India in Special Leave Petition (Criminal) Diary No. 35524/2019, Khursheed Ahmad V/s. State of Uttar Pradesh.

The Application/Proposal by the Advocates practising at the Nagpur Bench duly filled in the prescribed form, may be submitted in the office of The Registrar Administration, Nagpur Bench till 21<sup>st</sup> September 2020 on all working days between the office hours.

The applications/ proposals must be supported by the photo- copy of Sanad and Identity Card issued by the Bar Council of Maharashtra & Goa.

The eligibility criteria for the concerned Advocates for conducting appeals is prescribed as under:

| Sr. No. | Category                                | Eligibility   |
|---------|---|---|
| 1       | Conviction upto 7 years                 | 3 to 7 years of practice at the High Court of Judicature at Bombay.   |
| 2       | Conviction upto 10 years.               | 5 to 7 years of practice at the High Court of Judicature at Bombay.   |
| 3       | Sentence of Life Imprisonment and Death | Practice of 10 years and above at High Court of Judicature at Bombay. |

The applicant shall send the scanned copy of the duly filled in prescribed proforma on or before 21.9.2020 by Email on address "[hcnag.mah@nic.in](mailto:hcnag.mah@nic.in)" and simultaneously original of prescribed proforma be sent by Speed Post or physically to the office of the Registrar Administration, High Court of Judicature at Bombay Nagpur Bench, Civil Lines Nagpur. 440001.

Apart from the above exercise the Court may appoint Amicus Curiae in the interest of justice.
