NOTIFICATION

No. Rule/0705/2023.—In exercise of the powers conferred under article 227 and 235 of the Constitution of India, the Hon'ble the Chief Justice and the Judges of the Bombay High Court are pleased to direct that the following amendment shall be made in the Civil Manual *w.e.f.* 27.10.2023 which were carried out *vide* previous High Court Notification No. Rule/0705/2023, dated 19.08.2023 :—

## (1) In Rule 8, Appendix A, Paragraph 577 (iii) of Civil Manual—

Eligibility Criteria No. (III) for the posts of Stenographer (Grade-3), Junior Clerk and Peon/Hamal be substituted as under :

(III) Candidate shall not be eligible for appointment if he/she has been convicted for an offence involving moral turpitude or he/she is or has been permanently debarred or disqualified by the High Court/District Court or the Union Public Service Commission or any State Public Service Commission from appearing for examinations or selections conducted by it.

## (2) Insert new Rule 9A below Rule 9, Appendix A, Paragraph 577 (iii) of Civil Manual—

**Rule 9A Declaration**—Candidate should disclose whether he/she has been arrested or

detained or convicted for any offence, pendency of FIR/Criminal Complaint or decided criminal case against him/her or whether he/she is facing or has been held guilty in, disciplinary enquiry.
