(ii) Non compliance of (i) would entail rejection of the praecipe.

(II) Excepting very urgent matters priority, for admission and final hearing shall be given to old matters.

(III) In regard to illegible and handwritten documents, legible / typed copies be circulated one day before the listing date.

(IV) English Translation of documents intended to be relied upon be kept ready to be handed over to the Court when the matter is called out.
