 - iii) showing his/her standing as a legal practitioner in Court **(Original)**.
 - iv) certifying that he/she is of good moral character from two respectable persons, whose names have been mentioned in the online application form [As per prescribed **Format No. - I**] **(Original)**.
 - v) certifying that he/she has sufficient knowledge of Marathi to enable him/her to speak, read, write and translate with facility from Marathi into English and vice versa **(Original)**.
