(3) Upon perusal of the praecipes, the Court will grant dates accordingly.

(4) In case of due matters, other than fresh petitions, the circulation praecipe will specify the date assigned to the matters and specific urgency in the context of the date assigned.

(5) If the date assigned by the Court on the praecipe is not acceptable, then parties should file another praecipe stating what is the urgency and why an earlier date should be assigned.

(6) Praecipe without these details will not be considered as properly submitted praecipe, and no cognizance thereof will be taken.

(7) Mentioning of the matter in the Court shall be permitted only in **exceptional circumstances when there is extreme urgency/production for the same day.**

(8) Praecipe should be sent on court24@bhc.gov.in e-mail Id only on which the date shall be assigned.
